RESOLUTION NO. 205

The Board, on motion of Councilor Victorino C.
Teleron seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED TO approve Ordinance No. 8 series
of 1950, as follows:

ORDINANCE NO. 8

AN ORDINANCE PROHIBITING ANY PERSON FROM TAKING
A BATH OR WASHING PUBLIC ARTESIAN WELLS, PUBLIC
FAUCETS, AND THE LIKE.

Be it ordained by authority of the Municipal Board
of the City of Ormoc:

SEC. 1.-It shall be unlawful for any person to
take a bath and / or wash clothes in public artesian
wells, public faucets, fire hydrants, and the like.

SEC. 2.-Any violation of this ordinance shall,
upon conviction by the Municipal Court, be fined in an
amount ranging from P1.00 to P5.00, at the discretion
of the Court and in case of insolvency to suffer an
imprisonment at the rate of P2.50 per day.

SEC. 3.-This ordinance shall take effect upon its
approval.
