RESOLUTION NO. 204

The Board, on motion of Councilor Victorino C. Teleron,
seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED TO approve Ordinance No. 9, series of 1950
as follows:

ORDINANCE NO. 9

AN ORDINANCE REQUIRING BARRIO TENIENTES TO SECURE
PERMITS FROM THE CITY HEALTH OFFICER AS A PRE-RE-
QUISITE TO CELEBRATING THEIR ANNUAL BARRIO FIESTAS.

Be it ordained by authority of the City Board of
Ormoc City;

SEC. 1.-It shall be the duty of every barrio teniente
to apply for a permit from the City Health Officer certifying
to the existence of sanitary condition and the non-existence
of epidemic as a prerequisite to the holding of barrio annual
fiestas.

SEC. 2.-Such application as aforesaid shall be filed
with the City Health Officer at least two(2) weeks before
the celebration of the barrio fiesta and the permit may be
issued any time before the fiesta.

SEC. 3.-It shall be the duty of the City Health
Officer to conduct an ocular investigation of the premises
of the barrio proposing to celebrate its annual fiesta with
a view to determining the existence of the necessary sanitary
facilities and non-existence of communicable diseases before
any such permit be issued.

SEC. 4.-Such permit shall be issued upon payment of
the amount of ₱5.00 which shall be credited to the General
Fund.

SEC. 5.-It shall be unlawful to hold such annual
barrio fiesta without the requisite permits in the premises.

SEC. 6.-Any violation of this ordinance shall subject
the barrio officials concerned to administrative action and

dismissal.

SEC. 7.-This ordinance shall take effect upon approval.
