BE IT RESOLVED as it is hereby resolved to amend
Section 1 of Ordinance No. 5 series of 1950.

ORDINANCE NO. 2

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. ~~10~~⁵
SERIES OF 1950.

Be it Ordained by the Municipal Board of Ormoc City, and
by authority of the same, that;

SECTION 1.-Henceforth Section 1, of Ordinance No. 5
series of 1950 is hereby amended to include barbershops
and beauty parlors and all persons working therein so as
to read as follows:

SEC. 1.-In order to safeguard the Health and
promote the welfare of the public, henceforth,
all employees, laborers and helpers in any cafe,
restaurant, hotel, bakeries, sará-sará stores,
beverages stores, carinderias, panciterias, barber-
shops, beauty parlors, refreshment parlors, fish and
meat vendors and ambulant food vendors, and any
person now engaged or hereafter may engage in
the manufacture and sale of any kind of foods,
operated within the jurisdiction of the City of
Ormoc, shall submit for medical or physical exami-
nation to the Health Officer of this city or his
authorized representatives once every three months
renewable thereafter.

SECTION 2.-Fees: Fees prescribed in Section 2, of
Ordinance No. 5, series of 1950 is hereby imposed.

SECTION 3.-Penalty: Penalties prescribed for persons,
firm, company or corporation in Section 3 of the afore-
mentioned ordinance is imposed.

SECTION 4.-Repeal: Section 1, of Ordinance No. 5 series of 1950 is hereby repealed.

SECTION 5.-Effectivity: This ordinance shall take effect immediately upon its approval.

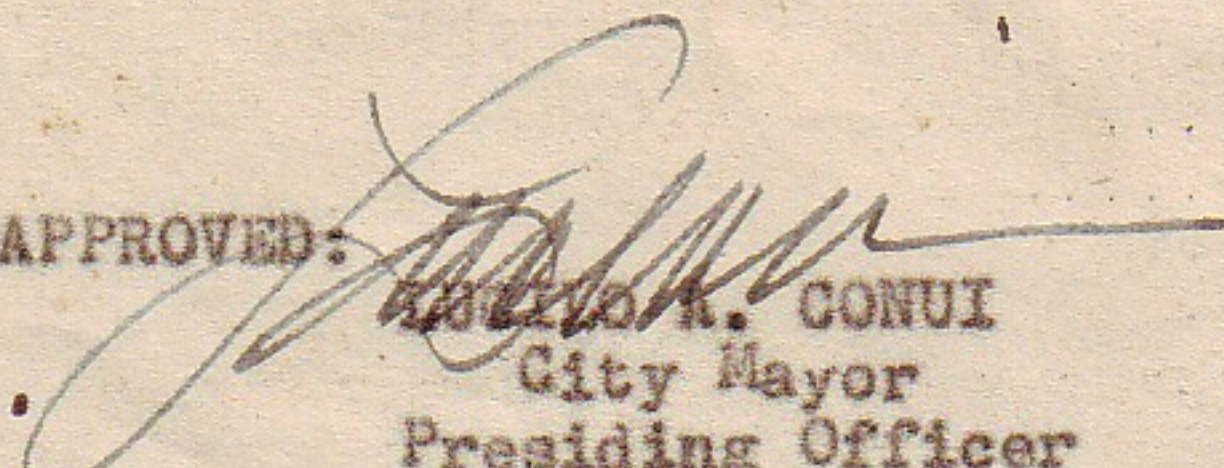
