AN ORDINANCE AMENDING SECTION I & IV  
OF ORDINANCE NO. IV, C.S.

be it ordained by the Municipal Board of Ormoc City  
that:

SECTION I.- Section I, Ordinance No. IV, current  
series is hereby amended to read as follows:

"SECTION I.- x x x x x pigs loaded at Ormoc  
City to be transported to other places coming  
from Ormoc City and other Municipalities shall  
pay loading and transportation fees as follows:

x x x

x x x

Pigs- - - - - P5.00 per head

the corresponding transportation fees to be paid  
in accordance with the bill of lading provided for  
by the Shipping Agency."

SECTION II.- Section IV, Ordinance No. IV, current  
series is hereby amended to read as follows:

"SECTION IV.- Any person or persons, firm or  
corporation violating or assisting in the violation of  
this ordinance shall, upon conviction, be fined not more  
than P200.00 or an imprisonment of not less than ten (10)  
days, or both such fine and imprisonment at the discre-  
tion of the Court."

SECTION III.- This amendment shall take effect im-  
mediately upon its approval.

SECTION IV.- All other provisions in any other ordi-  
nance inconsistent herewith is hereby repealed.
