The Board, on motion of Councilor Victorino C. Teleron,
seconded by Vice-Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to adopt;

ORDINANCE NO. XI

AN ORDINANCE REQUIRING THAT EACH HOUSE
IN THE POBLACION OF ORMOC CITY PRO-
VIDE A MINIMUM OF THREE PAIRS AND
NOT MORE THAN TEN PAIRS TO BE
PAINTED RED TO BE USED EX-
CLUSIVELY IN CASE OF FIRE
OR ANY EMERGENCY CASE.

Be it ordained by the Municipal Board of Ormoc
City that:

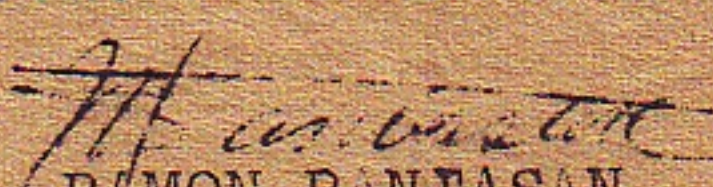
SECTION I.- Each house in the Poblacion of Ormoc
City should provide a minimum of three pairs and not
more than ten pairs to be painted red to be used exclu-
sively in case of fire or any emergency.

SECTION II.- Any person or persons, firm or corpo-
ration, violating or assisting in the violation of this
ordinance; shall, upon conviction, be fined not more than
Ten Pesos (P10.00) or an imprisonment of from one to ten
days or both such fine and imprisonment at the discretion
of the Court.

SECTION III.- This ordinance shall take effect thirty
days from the date of approval subject to the inspection
of the personnel of the fire department.

SECTION IV.- Let copies of this ordinance be furnished
each to the Hon. Executive Secretary, Malacañan Palace,
Manila; the Hon. City Mayor, Ormoc City; City Treasurer,
Ormoc City; City Auditor, Ormoc City; City Attorney, Ormoc
City; Municipal Judge, Ormoc City; Chief of Police, Ormoc
City and copies to be posted in public places, Ormoc City
CARRIED UNANIMOUSLY.
