RESOLUTION NO. 162

The Board, on motion of Councilor Iñaki Larrazabal,  
seconded by Councilor Esteban G. Conejos;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. ALV.

AN ORDINANCE LIMITING MAXIMUM SPEEDS OF  
MOTOR VEHICLES OPERATING OUTSIDE  
THE CITY AND ALSO IN THE POBLACION

*Reappendedly Executive  
Secretary Speed limit  
prescribed by the prov. of  
Poblacion Pub. Works Dept  
be followed*

Be it ordained by the Municipal Board of Ormoc City,  
that:

SECTION I. - All motor vehicles operating outside  
the city and in the poblacion (city proper) shall strictly  
observe the following speed limits:

- (a) Motor vehicles operating in highways outside  
the city shall have a maximum speed of thirty  
(30) kilometers per hour.
- (b) Motor vehicles operating in the poblacion  
(city proper) of Ormoc City shall have a maxi-  
mum speed of ten (10) kilometers per hour.

SECTION II. - PENALTY. Any person or persons violating  
or assisting in the violation of this ordinance, shall,  
upon conviction be fined ten pesos (\$10.00) or an imprison-  
ment of not more than ten (10) days, or both such fine and  
imprisonment at the discretion of the Court.

SECTION III. - Any provision or provisions of other  
ordinances inconsistent herewith is hereby repudiated.

SECTION IV. - This ordinance shall take effect on  
the 20th day of November, 1952.

SECTION V. - Let copies of this ordinance be fur-  
nished each to the Hon. Executive Secretary, Malacañan  
Palace, Manila; the Hon. City Mayor, Ormoc City; all  
department heads, Ormoc City and copies to be posted  
in public places, Ormoc City.
