RESOLUTION NO. 170

The Board, on motion of Councilor Jorge S. Tan, seconded by Councilor Esteban C. Conejos;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. XV

AN ORDINANCE PROHIBITING DRIVERS AND TRUCKMEN TO GIVE, DONATE OR THROW SUGAR CANE TO ANY PERSON AND TO DECLARE AN OFFENSE OR CRIME THE TAKING OUT, EXTRACTING, OR PULLING OF SUGAR CANE FROM ANY TRUCK LOADED WITH SUGAR CANE AND TO PROHIBIT FURTHER THE CHEWING OF SUGAR CANE IN CITY STREETS

Be it ordained by the Municipal Board of Ormoc City, that:

SECTION I. - It would be unlawful for any driver or truckman of sugar cane-loaded trucks to donate, throw or give sugar cane to any person or persons.

SECTION II. - Taking out, extracting, or pulling of sugar cane from any truck loaded with sugar cane and the chewing of sugar cane in city streets and in any other public place is prohibited.

SECTION III. - Any person or persons violating or assisting in the violation of this ordinance, shall upon conviction be fined not less than ₱5.00 or an imprisonment of not more than two (2) days, or both such fine and imprisonment, at the discretion of the Court.

SECTION IV. - This ordinance shall take effect immediately upon its approval.

SECTION V. - Let copies of this ordinance be furnished each to the Hon. Executive Secretary, Malacañan Palace, Manila; the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; all other department heads, Ormoc City and copies to be posted in public places, Ormoc City.
