RESOLUTION NO. 190

The Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Vice Mayor Marcelo D. Bandalan;

Be it resolved to approve Ordinance No. 16 series of 1952 as follows:

ORDINANCE NO. XVI

AN ORDINANCE REQUIRING ALL RIG DRIVERS IN THE CITY OF ORMOC TO PROVIDE THEMSELVES WITH A CONTAINER FOR THE MANURE OF THEIR HORSES DURING THE COURSE OF THEIR OPERATION TO PREVENT THE SPREAD OF MANURE ALONG THE CITY STREETS.

Be it ordained by authority of the Municipal Board of the City of Ormoc:

SEC. 1.- All rig drivers in the City of Ormoc shall provide themselves with a container for the manure of their horses during the course of their operation to prevent the spread of manure along the city streets.

SEC. 2.- Any violation of this ordinance shall, upon conviction by the Municipal Court, be fined ~~of not~~ more than TWO PESOS (P2.00) or an imprisonment of not more than one (1) day or both such fine and imprisonment at the discretion of the court.

SEC. 3.- This ordinance shall take effect upon approval.

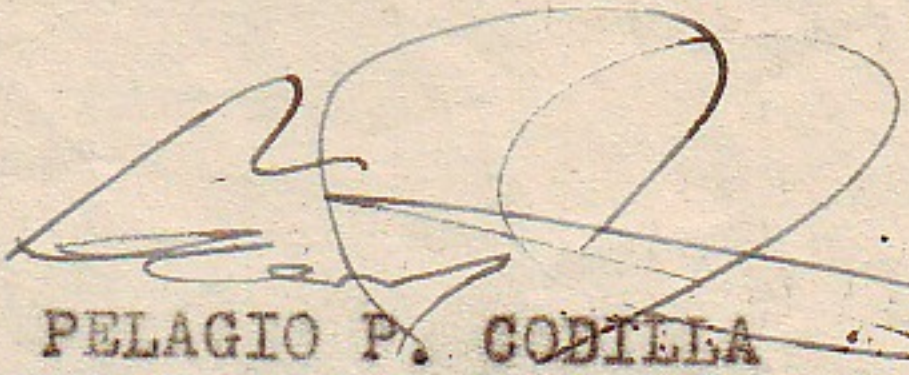
