

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. XVII

AN ORDINANCE PROHIBITING THE ADMIS-
SION TO MOVIEHOUSES AND RECREATIONAL
CENTERS OF CHILDREN BELOW 12 YEARS OF
AGE

Repealed by other ordinance No. II s. 1953

Be it ordained by the Municipal Board of Ormoc City,
that:

SECTION I.- The admission of children below 12 years to moviehouses and similar recreational centers is hereby prohibited.

SECTION II.- The operator of moviehouses and similar recreational centers shall, in the event of conflict of opinion as to the age of the child, have its opinion given greater weight in determining the age of children who shall not be allowed admission to said moviehouses or similar recreational centers.

SECTION III.- The operation of this ordinance shall be for a period until the City Health Officer shall recommend to the City Mayor, who in turn will recommend to the Municipal Board for the lifting of the operation of this ordinance.

SECTION IV.- Persons responsible for violation of this ordinance shall be the following:

1. Parents or guardians who shall bring the child to such moviehouse or recreational center.
2. Any person who shall facilitate the admission of the child below 12 years old.
3. In the event the child below 12 years old who is found to have been admitted to such moviehouse or recreational center shall not have been accompanied by their parents or guardians or whose admission shall not have been facilitated by any other person, then the operator or its employee shall be the one responsible for the violation.

SECTION V.- Penalty: Any person, firm or corporation violating or assisting in the violation of this ordinance, shall upon conviction be fined not more than P10.00 or subsidiary imprisonment in case of insolvency.

SECTION VI.- Effectivity: This ordinance shall take effect January 7, 1953.

SECTION VII.- Let copies of this ordinance be furnished each to the Hon. Executive Secretary, Malacañan Palace, Manila; the Hon. City Mayor, Ormoc City; City Treasurer, City Auditor, City Engineer, City Attorney, City Health Officer, Municipal Judge, Chief of Police, Fire Chief, and to the different public and private schools of Ormoc City with the request to give the same wide publicity to school
