LIVERY AN ORDINANCE PROVIDING FOR LOADING AND FROM ORMOC CITY AND OTHER MUNICIPAL

Be it ordained by the Municipal Boaed of Ormoc City that:

SECTION I .- Carabaos, cows, horses and pigs loaded at Ormoc City to be transported to other places coming from Ormoc City andother Municipalities shall pay loading and transportation fees as follows:

6.00 per head Carabaos ..... 4.00 5.00 Horses ................ 2.00 1 Pidgs ....... For small pige for lechon and breeding purposes and not for commercial purposes not exceeding three (3) 1.00 per head

SECTION. II .- Any person or persons, firm or copporation violating or assisting in the violation of this ordinance shall, upon conviction, be fined not more than THIRTY (₱30.00) PESOS or an imprisonment of mot more than Ten (10) days, or both fine and imprisonment at the discretion of the Court.

SECTION III. All other provision or provisions in any ordinace inconsistent herewith are hereby repealed

SECTION IV. -This ordinance shall take effect immeditately upon its approval.
