ORDINANCE NO. III

AN ORDINANCE PROVIDING FOR LOADING AND
TRANSPORTATION FEES OF CARABAOS, COWS,
HORSES AND PIGS LOADED AT ORMOC CITY TO
BE TRANSPORTED TO OTHER PLACES COMING
FROM ORMOC CITY AND OTHER MUNICIPALITIES

Be it ordained by the Municipal Board of Ormoc
City that:

SECTION I.-Carabaos, cows, horses and pigs loaded
at Ormoc City to be transported to other places coming
from Ormoc City and other Municipalities shall pay load-
ing and transportation fees as follows:

Carabaos.....	P 6.00 per head
Cows.....	4.00 " "
Horses.....	5.00 " "
Pigs.....	2.00 " "
For small pig for lechon and breed- ing purposes and not for commercial purposes not exceeding three (3)	1.00 per head

SECTION. II.- Any person or persons, firm or corp-
oration violating or assisting in the violation of this
ordinance shall, upon conviction, be fined not more
than THIRTY (P30.00) PESOS or an imprisonment of not
more than Ten (10) days, or both fine and imprisonment
at the discretion of the Court.

SECTION III. All other provision or provisions
in any ordinance inconsistent herewith are hereby
repealed

SECTION IV. -This ordinance shall take effect
immediately upon its approval.
