ORDINANCE NO. IV

AN ORDINANCE TO AMEND SECTION 1
OF ORDINANCE NO. III, CURRENT
SERIES

Be it ordained by the Municipal Board of Ormoc City that:

SECTION I. Section I, Ordinance No. III, current series is hereby amended to read as follows:

"SECTION I.- x x x x x x x x pigs loaded at Ormoc City to be transported to other places coming from Ormoc City and other Municipalities shall pay loading and transportation fees as follows:


SECTION V. All other provision or provisions in any other ordinance inconsistent herewith is hereby repealed.
