RESOLUTION NO. 84

The Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved to adopt:

ORDINANCE NO. V

AN ORDINANCE PROVIDING FOR THE
ABATEMENT OF NUISANCE, DISPOSI-
TION OF GARBAGE AND REFUSE

Be it ordained by the Municipal Board of Ormoc City that:

SECTION I.- Whatever is dangerous to human health, whatever renders the ground, air, or food a hazard or injury to human health, and the following specific acts, conditions, and things are each and all of them hereby declared to constitute a "NUISANCE".

- a. Spitting upon any sidewalk or on the floor or wall of any public building specially in the public market, sidewalk, cines, boat, trucks and other vehicles of public convenience.
- b. The accumulation of water in which mosquito larvae breed.
- c. The urinating and defecating in any place outside the known and recognized sanitary toilet by the Department of Health personnel.
- d. The disposal or accumulation of any foul, decaying, or putrescent substances or other offensive materials dangerous to public health in or upon any lot, street, sidewalk, or highway, or the escape of any gas to such an extent that the same or any of them shall by reason of offensive odors become injurious to the health of any person.

- e. The deposit or accumulation of manure (shall include all excreta of any domestic animals, live-stock, fowl, pigs, etc.) unless it be in fly-proof receptacles.
- f. The bathing and washing of clothes or utensils in the platform of artesian wells.
- g. The deposit of garbage in any place but not fly-proof, water-tight receptacles.
- h. Displaying and selling decayed meat, fish, vegetables, fruits and other substances dangerous to human health.
- i. Any act, omission or thing which is or may be dangerous to life or injurious to health.

SECTION II.- The term "GARBAGE" shall include all combustible matter which is liable to ferment, decay, putrefy, decompose or become offensive or a menace to health, and the refuse matter from kitchen, dining rooms, and other parts of hotels, restaurants, paniterias, catterias, boarding houses, market houses, and the refuse fruits and vegetables from fruit stands, markets, and groceries, animal matter, any particle of meat unfit or not intended for immediate market and to be subjected to a rendering process.

SECTION III.- The throwing of residue such as: chewed sugar cane, banana peel (panit), corn peel (pac-pac), worn shoe (agungal), nangka peel which breed flies and other insects in the streets, sidewalks, plazas and the floor of public markets are hereby prohibited. The same must be placed in garbage receptacles.

SECTION IV.- The term "REFUSE" shall include all yard screenings, dirt, rags, waste paper, metal cans, broken glasses, porcelain, cutted hair (barber shops and beauty parlors), dead animals, rubbish, ashes, excretas (human or animal) and all other unsightly materials, and must be disposed off by burying, filling, incineration or to be placed in the garbage receptacles displayed in the corner of streets.

SECTION V.- Any person or persons violating or assisting in the violation of any part or parts of this ordinance shall, upon conviction, be fined not more than Ten Pesos (P10.00) or by imprisonment of not more than Five (5) days, or by both such fine and imprisonment at the discretion of the Court.

SECTION VI.- This ordinance shall take effect immediately upon its approval.

SECTION VII.- Let copies of this ordinance be furnished to the Hon. Executive Secretary, Malacañan Palace, Manila; the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; Municipal Judge, Ormoc City; City Attorney, Ormoc City; Chief of Police, Ormoc City; City Health Officer, Ormoc City; City Engineer, Ormoc City; Market Superintendent, Ormoc City; and copies to be posted in public places, Ormoc City.

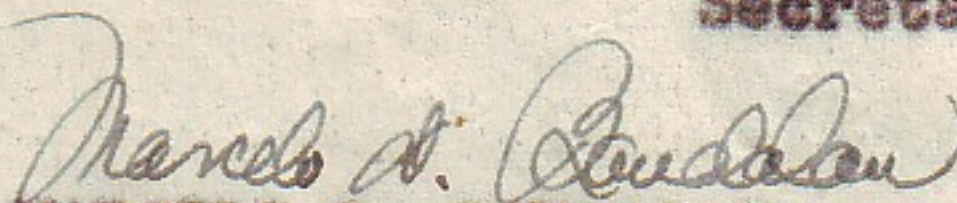

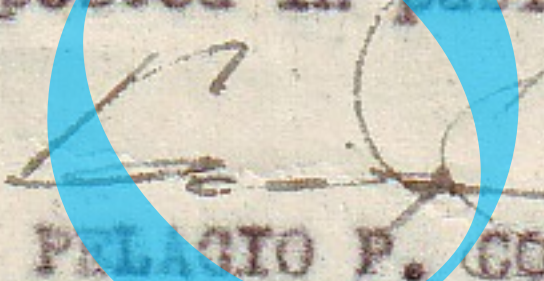
