BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. VII

AN ORDINANCE PROHIBITING THE BLOWING OF HORNS
OF TRUCKS, AUTOMOBILES AND OTHER MOTOR VEHICLES AFTER
TEN O'CLOCK IN THE EVENING AND BEFORE SEVEN O'CLOCK IN
THE MORNING AND TO PROHIBIT THE USE OF LOUD SPEAKERS
EXCEPT DURING PROGRAMS, PUBLIC MEETINGS AND OTHER
SPECIAL OCCASIONS BY MEANS OF A PERMIT FROM THE HONOR-
ABLE CITY MAYOR

Be it ordained by the Municipal Board of Ormog City that:

SECTION I. Blowing of horns of trucks, automobiles and
other motor vehicles is prohibited after ten o'clock in the
evening and before seven o'clock in the morning;

The use of loud speakers is also prohibited except
during programs and public meetings and other special occa-
sions by means of a permit from the Honorable City Mayor;

SECTION II. Any person or persons, firm or corporation,
violating or assisting in the violation of this ordinance,
shall, upon conviction, be fined not more than P10.00 or an
imprisonment of not more than five (5) days or both such fine
and imprisonment at the discretion of the Court.

SECTION III. This ordinance shall take effect immediately
upon its approval.

SECTION IV. Let copies of this ordinance be furnished to
the Hon. Executive Secretary, Malacañan Palace, Manila; the
Hon. City Mayor, Ormog City; City Treasurer, Ormog City; City
Auditor, Ormog City; City Attorney, Ormog City; Municipal
Judge, Ormog City; Chief of Police, Ormog City and copies to
be posted in public places, Ormog City.

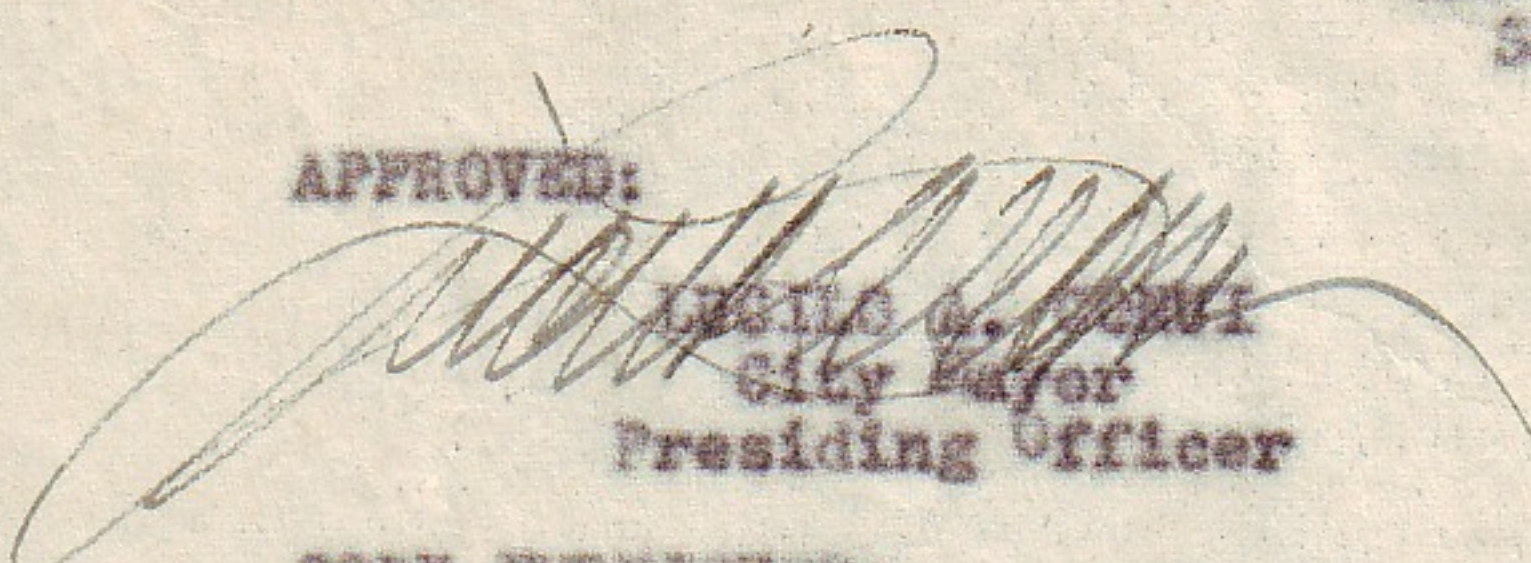
