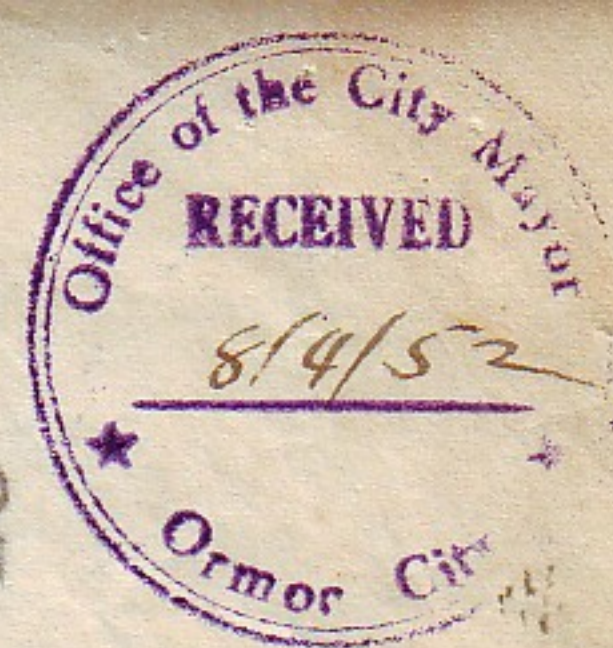

RESOLUTION NO. 115

The Board, on motion of Councilor Alvaro I. Gutierrez
seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved to adopt;

ORDINANCE NO. 10

AN ORDINANCE MAKING IT ILLEGAL AND PROVIDING FOR A PENALTY
ON ANY ONE, OTHER THAN THOSE AUTHORIZED BY THE CITY ENGINEER
WHO IS FOUND CHANGING THE HANDLE, LOOSENING THE BOLTS,
UNSCREWING THE GOOSE-NECK, OBSTRUCTING THE DRAIN OR IN
ANY WAY INTERFERING WITH THE NATURAL WORKING OF AN ARTESIAN
WELL, DRAINAGE PIPES OR DITCHES, AND ON ANY ONE FOUND
WASHING CLOTHES, BATHING OR LETTING HIS ANIMAL DRINK IN
ANY PUBLIC ARTESIAN WELL.

Be it ordained by the Municipal Board of Ormoc City
that:

SECTION I.- No person or persons other than those
authorized by the City Engineer shall change the handle,
loosen the bolts, unscrew the goose-neck, obstruct the
drain or in any way interfere with the natural working
of an artesian well, drainage pipes or ditches.

SECTION II.- No person or persons is allowed to
wash their clothes, take a bath or let his animal drink
in any public artesian well.

SECTION III.- Any person or persons, firm or corp-
oration found violating or assisting in the violation
of this ordinance shall, upon conviction, be fined not
more than TEN (P10.00) PESOS or an imprisonment of not
more than FIVE (5) days or both fine and imprisonment
at the discretion of the court.

SECTION IV.- This ordinance shall take effect
immediately upon its approval.

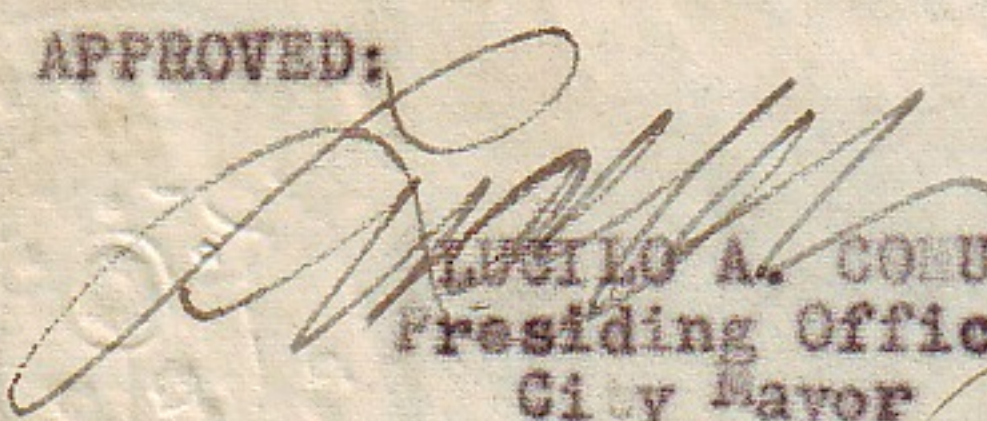
