BE IT RESOLVED, as is hereby resolved to adopt:

ORDINANCE NO. I

AN ORDINANCE TO AMEND PARAGRAPH FOUR
SECTION SIX OF ORDINANCE NO SIX, SE-
RIES OF 1948

Be it ordained by the Municipal Board of Ormoc
City that:

SECTION I.-Paragraph four, Section Six of Ordi-
nance numbered Six, series of 1948 is hereby amended
to read as follows:

"Sec. 6. x x x x x x x x x

"All connections from the stop cock
at the property line up to any faucet in
the house or establishment except the meter
stand shall be made by licensed plumbers
and shall be subject to the inspection
and price approval of the waterworks sys-
tem or its authorized representative."

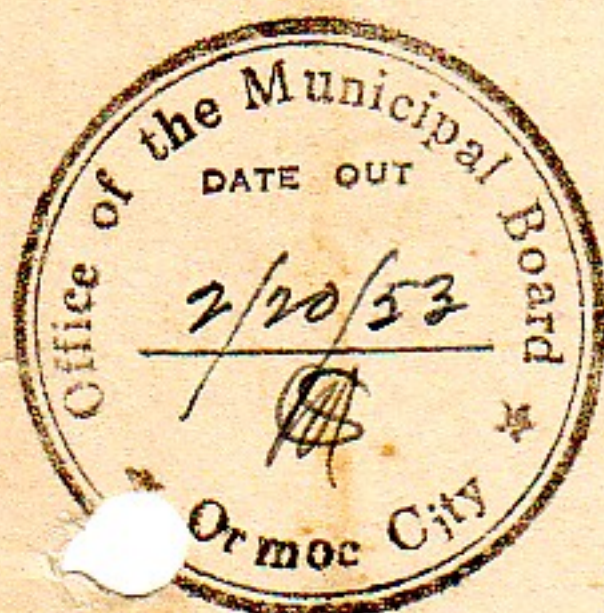
SECTION II.-Any person or persons, firm, company,
violating or assisting in the violation of the
provisions of this ordinance shall be punished in
accordance with the penalty provisions of Ordinance
numbered six, series of 1948.

SECTION III.-This ordinance shall take effect
immediately upon approval.


