RESOLUTION NO. 115

WHEREAS, be it known that Fire plugs or hydrants situated on private property in warehouses, installed by consumer are charged for at the rate of P3.00 per month, as cited in Section 17, Ordinance No. 6, series of 1948 of this Municipal Board;

WHEREAS, that this private installed Fire plugs or hydrants has helped us during the great fire last year, and thus Section 17, Ordinance No. 6 be amended to exempt those individual with Fire plugs or hydrants installation from taxation;

NOW THEREFORE, the Board, on motion of Councillor Alvaro I. Gutierrez seconded by Councillor Emilio C. Penserga;

BE IT RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 1

AN ORDINANCE AMENDING SECTION 17 OF ORDINANCE NO. 6
SERIES OF 1948

Be it ordained by the Municipal Board of the City of Ormoc,
That:

SECTION 1. Fire plugs or hydrants situated on private property in warehouses, etc, shall be installed by the consumer after having secured the necessary permit, subject to the supervision of the Waterworks.

Each such fire plug will be sealed by the employees of the Waterworks System when installed and water therefrom shall not be used except in case of fire.

No charge will be made for water used from these fire plugs in case of fire, trial operation or practice in order to accustom the owners to operate their fire hose in case of emergency.
