BE IT RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. XI

AN ORDINANCE PROHIBITING ALL FISHERMEN WITH BAROTOS AND
BANCAS ESPECIALLY THOSE WITH NETS TO FISH ALONG THE SIDE
OF THE PIER AT A DISTANCE OF 100 METERS FROM ALL SIDES
OF THE PIER

Be it ordained by the Municipal Board of Ormoc City
that:

SECTION 1. All fishermen with bancas and barotos
especially those with nets is prohibited to fish along
the pier at a distance of 100 meters from all sides of the
Pier.

SECTION 2. Any person or persons violating this
Ordinance, shall, upon conviction, be fined not more than
P50.00 or an imprisonment of not more than 15 days, or both
such fine and imprisonment at the discretion of the Court.

SECTION 3. This Ordinance shall take effect immediately
upon its approval.

SECTION 4. Let copies of this Ordinance be furnished
to the Hon. Executive Secretary, Malacanan Palace, Manila;
the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City;
City Auditor, Ormoc City; City Attorney, Ormoc City; Muni-
cipal Judge, Ormoc City; Chief of Police, Ormoc City and
copies to be posted in public places, Ormoc City.

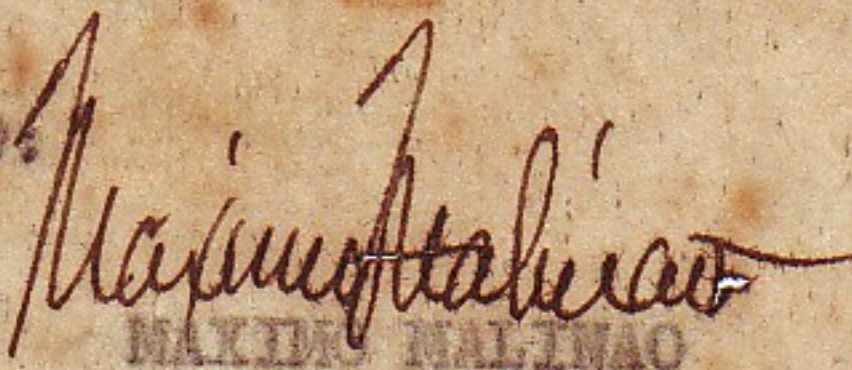
