RESOLUTION NO. 16

WHEREAS, be it known that the Municipal Board of Ormoc City in its Special Session held on December 29, 1952 passed Resolution numbered 197 adopting Ordinance numbered 17 prohibiting the admission of children below 12 years to moviehouses and similar recreational centers due to the prevalence of influenza in the locality;

WHEREAS, Dr. Butiquiano Field, Asst. City Health Officer of Ormoc City being present during the deliberation informed the Hon. members of the Board that cases of influenza in the locality had subsided; and recommended to the Hon. Body to amend certain sections of Ordinance No. 17 so that only children below three years instead of below twelve years will not be admitted to moviehouses and similar recreational centers;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Alvare I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. II

AN ORDINANCE AMENDING SECTIONS
I & IV(2) & (3) OF ORDINANCE
NUMBERED XVII, SERIES OF 1952

Be it ordained by the Municipal Board of Ormoc City,
that:

SECTION I. Sec. I, Ordinance No. 17, series 1952
is hereby amended to read as follows:

"SECTION I. The admission of children below 3
years to moviehouses and similar recreational
centers is hereby prohibited."

SECTION II. Sec. VI(2) & (3), Ordinance No. 17,
series 1952 is hereby amended to read as follows:

"Section IV. Persons responsible for violation
of this ordinance shall be the following:

X X X X

2. Any person who shall facilitate the
admission of the child below 3 years old.



3. In the event the child below 3 years
old x x x x x

SECTION III. Penalty. Any person, firm or corporation violating or assisting in the violation of this ordinance shall be punished as provided for in Section V of Ordinance No. 17, series of 1952.

SECTION IV. This ordinance shall take effect upon approval.

SECTION V. Let copies of this ordinance be furnished each to the Hon. Executive Secretary, Malacañan Palace, Manila; the Hon. City Mayor; City Treasurer; City Auditor; City Attorney; City Health Officer; Municipal Judge; City Engineer; Chief of Police; Fire Chief; Ormoc City and the different private and public schools of Ormoc City.
