RESOLUTION NO. 21

WHEREAS, the parking of trucks loaded with canes at barrio Ipil, Ormoc City, exposes the people of Ipil, specially the children to accident as some of them, while playing between the trucks would run out and may be caught by passing cars because the drivers cannot see them;

WHEREAS, Ipil has already lost one child in the manner stated above;

WHEREAS, the parking of trucks loaded with canes cause the destruction of the asphalted road because the wood used by the drivers to relieve the pressure of their tires supporting their trucks pierced the asphalt pavement as can be seen by the traces found therein;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Victorino C. Teleron;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. III

AN ORDINANCE DESIGNATING PARK-
ING PLACES AT BARRIO IPIL, ORMOC
CITY

Be it ordained by the Municipal Board of Ormoc City, that:

SECTION I. It is prohibited to park trucks loaded with canes at barrio Ipil from the bridge at Ipil Creek to the point of the road at Derrick No. 1 of the Ormoc Sugar Central and at other streets at the barrio proper;

SECTION II. Trucks loaded with canes will be parked at the streets from Derrick No. 1 on one side of the street towards Tinag-an or at one side of the street from before the bridge at Ipil Creek towards Panalian river.

SECTION III. Penalty. Any person, firm or corporation violating or assisting in the violation of this ordinance shall be fined P5.00 or an imprisonment of not more than three days or both such fine and imprisonment, at the discretion of the Court.

SECTION IV. This ordinance shall take effect immediately upon its approval.

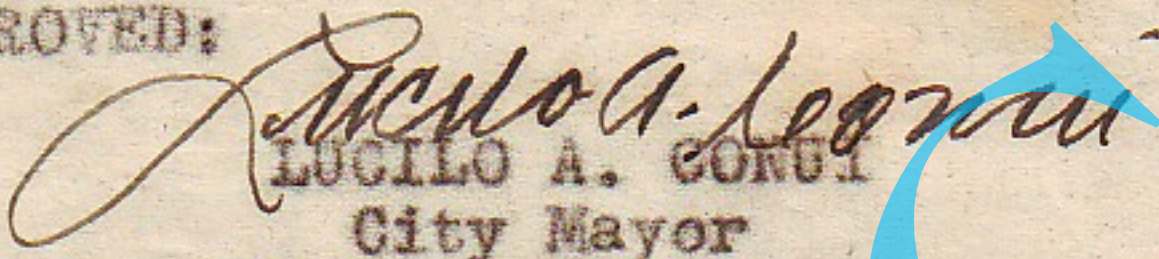

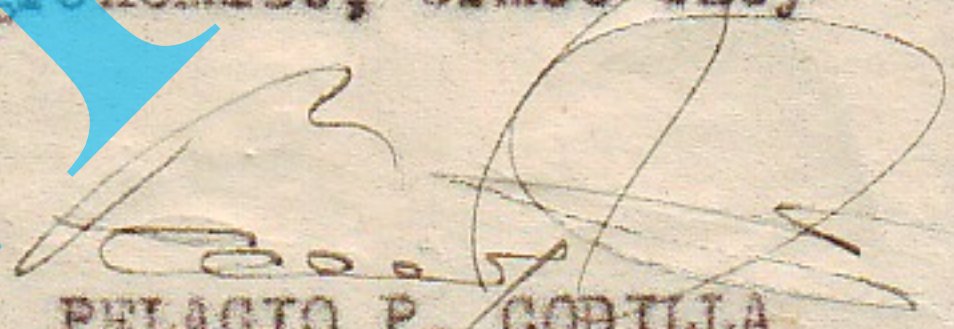
