RESOLUTION NO. 26

The Board, on motion of Councilor Iñaki Larrazabal,
seconded by Councilor Esteban C. Conejos;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. IV

AN ORDINANCE AMENDING SECTIONS
ONE, TWO, THREE, FOUR AND FIVE
OF ORDINANCE NUMBERED TWO, SE-
RIES 1950

Be it ordained by the Municipal Board of Ormog City,
that:

SECTION I. Sections 1, 2, 3, 4 & 5 of Ordinance numbered
two, series of 1950, is hereby amended to read as follows:

"SECTION 1. The words "ASTRAY ANIMALS" used in
this ordinance shall include all loose animals roam-
ing, destroying the appearance or orderliness of the
public places, as streets, plazas and private premises."

"SECTION 2. Every owner of animals must keep them
always tied properly; small animals to be tied or kept
in pens which are to be kept clean and sanitary to
prevent the disturbance of neighbors from obnoxious
odor."

"SECTION 3. The City Health Officer is the only
authorized official to appoint astray animal catcher
or catchers whose remuneration or emolument is one
peso (P1.00) for small animals (pigs, goats or sheeps)
and P3.00 for every large cattle (carabaos, cow, or
horses) caught."

"SECTION 4. For every pig, goat or sheep caught,
the owner has the obligation to pay P1.00 and P0.50
for each day of detention or fraction thereof in the
compound; and for every large cattle (carabao, cow
or horse) caught, the owner has the obligation to
pay P3.00 and P0.50 for each day of detention or
fraction thereof in the compound."

"SECTION 5. Any person or persons, firm or corporation, violating or assisting in the violation of the provisions of this ordinance, shall, upon conviction be fined not less than five pesos (P5.00) and not more than fifty pesos (P50.00) or by imprisonment of not less than five days but not more than fifty days, or both such fine and imprisonment at the discretion of the Court."

SECTION II. This ordinance shall take effect immediately upon its approval.


