RESOLUTION NO. 38

The Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Victorino C. Teleron;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. VI

AN ORDINANCE TO MAKE ORMOC CITY
HIGH SCHOOL SELF-SUPPORTING IN
ITS OPERATION

Be it ordained by the Municipal Board of Ormoc City, that:

SECTION I. Students enrolled in the Ormoc City High School from the first to fourth year will have to pay Eighty-Two Pesos (P82.00) for the whole year, Two Pesos (P2.00) of which will be the matriculation fee and the remaining balance of Eighty Pesos (P80.00) to compose the monthly tuition fees divided into ten (10) monthly installments, to be paid at the beginning of each month.

SECTION II. (a) There will be employed classroom teachers - three (3) teachers for every two (2) sections organized and five (5) for the last three (3) sections organized.

(b) Enrolment will be forty-five (45) students for the first year classes and fifty (50) for all others in the high school.

(c) Teachers' salaries will be paid from the tuition fees collected from the students. Clerical staffs will also be paid from the tuition fees.

(d) Matriculation fees will be utilized in accordance to law.

(e) Other expenses not mentioned above will be appropriated by the Municipal Board.

SECTION III. Any provision or provisions of any other ordinance inconsistent herewith are hereby repealed.

SECTION IV. This ordinance shall take effect upon its approval.

SECTION V. Let copies of this ordinance be furnished each to the Hon. Executive Secretary, Malacañan Palace, Manila; the Hon. City Mayor, Ormoc City; City Treasurer; City Auditor; the City Attorney; Municipal Judge; Chief of Police; Fire Chief; City Engineer and the Principal

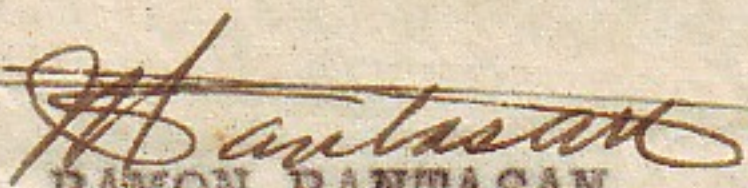

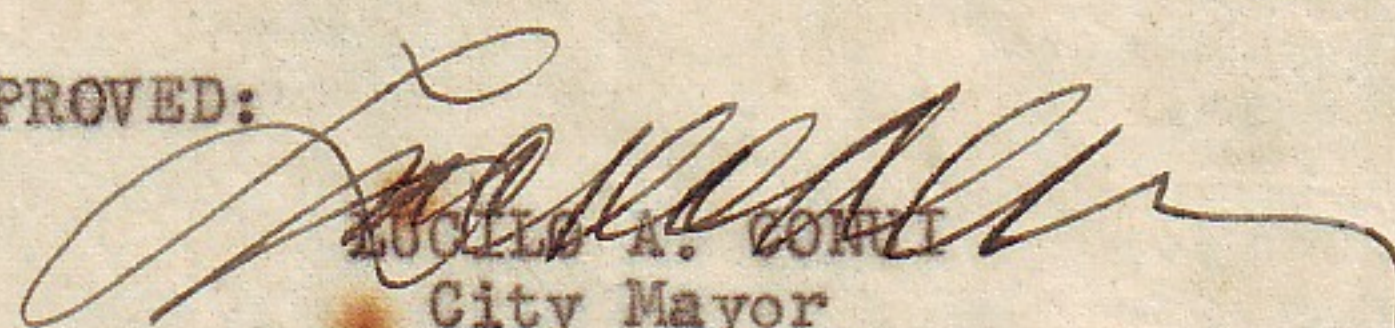
