RESOLUTION NO. 61

WHEREAS, the Municipal Board of Ormoc City passed resolution numbered 38, current series, adopting ordinance numbered six, fixing the tuition fees of the Ormoc City High School;

WHEREAS, Mr. Carlos Petilla, Principal, Ormoc City High School, being present during the deliberation informed the Honorable Members of the Board that the PTA of Ormoc City High School made a verbal petition reducing the tuition fees of the first year from P82.00 to P72.00;

WHEREAS, according to the principal, many students are willing to enroll in the first year if the petition of the parents of the school children reducing the tuition fees will be approved by the Municipal Board;

NOW THEREFORE, the Board, on motion of Councillor Victorino C. Teloron, seconded by Councillor Ugnaldo F. Laguitan;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. VII

AN ORDINANCE TO AMEND SECTION
ONE OF ORDINANCE NUMBERED SIX
CURRENT SERIES

Be it ordained by the Municipal Board of Ormoc City,
that:

SECTION I. - Section I, Ordinance numbered six,
current series is hereby amended to read as follows:

"SECTION I.-Students enrolled in the Ormoc City High School from the second year to fourth year will have to pay Eighty-Two Pesos (P82.00) for the whole year, Two Pesos (P2.00) of which will be the matriculation fee and the remaining balance of Eighty-Pesos (P80.00) to compose the monthly tuition fees divided into ten (10) monthly installments, to be paid at the beginning of each month.

Students enrolled in the first year will have to pay Seventy-Two Pesos (P72.00) for the whole year, Two Pesos (P2.00) of which will be the matriculation fee and the remaining balance of Seventy-Pesos (P70.00) to compose the monthly tuition fees to be paid in two (10) equal monthly installment payable at the beginning of each month."

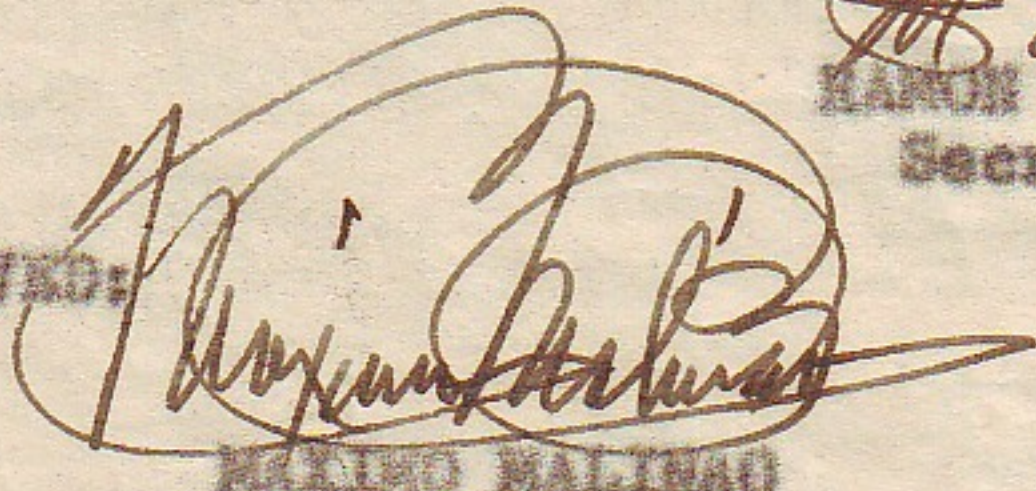
