BE IT RESOLVED, as it is hereby resolved, to adopt;

ORDINANCE NO. VIII

AN ORDINANCE AMENDING SECTION I OF ORDINANCE NO. 6  
SERIES OF 1950

Be it Ordained by the Municipal Board, this City that;

SECTION I.- Section 1 of sub-section "d" of Ordinance  
No. 6 series of 1950 is hereby amended so as to read as  
follows:

(d) Hereafter, all TPU trucks going north or northwest  
and going south, besides parking on the streets designated in  
Section 3, sub-sections "a" and "b" of Ordinance No. 10, the  
same are allowed to park along Bonifacio St. up to the Light-  
house only and along C. Aviles St., Burgos St. and Rizal Sts.  
Said TPU Trucks are allowed to enter at the Pier only to un-  
load cargoes. Said TPU Trucks are not allowed to pick up  
passengers at the pier or to load cargoes.

(e) Vehicles mentioned below are allowed to enter  
the pier to load and to unload cargoes, viz:

Provided however, that all vehicles hereby allowed to  
enter at Ormoc Pier from the lighthouse should not park at  
the pier longer than the time required for loading and un-  
loading cargoes and passengers, to avoid congestion of tra-  
ffic vehicles at Ormoc Pier.

SECTION 2.- Penalties: Any person firm or corporation  
found violating any provisions of this Ordinance shall suffer  
such fine and penalties as provided for in Section 4 of  
Ordinance No. 10.
