RESOLUTION NO. 20

WHEREAS, the peace and order condition of Ormoc City depends upon the efficiency of the Police Force;

WHEREAS, it is imperative that the qualifications of the Police Force be standardized so as to employ good materials into the service;

WHEREAS, from time to time vacancies occur in the Police Department, Ormoc City;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as it is hereby resolved, to adopt;

ORDINANCE NO. 1

AN ORDINANCE SETTING QUALIFICATIONS OF POLICEMEN  
TO BE APPOINTED BY THE CITY MAYOR

Be it Ordained by the Municipal Board, this City that;

SECTION I. Hence forth, policemen to be appointed by the City Mayor to fill up vacancies that may occur should possess the following qualifications:

- (a) Must be between 21 and 60 years of age, and physically in good health as attested by Physicians.
- (b) Height and weight same standard followed by the AFP or PC.
- (c) At least a High School Graduate (of any secondary course recognized by the Government) or two years of service in the Army, Philippine Constabulary, Philippine Scouts, United States Army or City Police Force for any year deficiency for High School Graduation.
- (d) Must not have been convicted of any crime.
- (e) Must neither be drunkard nor a gambler as attested by any reputable citizen of Ormoc City who will be responsible for such applicant.
