RESOLUTION NO. 45

WHEREAS, the people of Barrio Ipil, Ormoc City have petitioned that no trucks loaded with sugar cane be allowed to park inside the barrio except the street from Mr. Salapantan's store up to Tinag-an and from the barrio bridge up to Panalian river;

WHEREAS, this matter after careful study by the Traffic Division of the Police Department, the latter has found out that the same would be very inconvenient to the drivers, considering the distance they have to walk from Panalian river to the sugar central to get their ticket numbers;

WHEREAS, the Police Department has recommended a solution to the traffic problem at Barrio Ipil which would, for the present, ease such problems to the convenience of both the residents of the barrio and sugar-cane truck drivers;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. II

AN ORDINANCE REGULATING THE PARKING
PLACE OF SUGAR-CANE TRUCKS AT BAR-
RIO IPIL, ORMOC CITY

Be it ordained by the Municipal Board of Ormoc City, that:

SECTION: I - Henceforth, all trucks loaded with sugar cane for delivery to the Ormoc Sugar Central shall park only along one side of the public highway at Barrio Ipil, Ormoc City in the following manner:

(a) All trucks coming from the poblacion towards Barrio Ipil shall park at the right side of the road inside the barrio up to the Central except that the space directly in front of the barrio elementary school covering a distance of seventy-five (75) meters; and

(b) All trucks coming from Tinag-an towards Barrio Ipil shall park at the right side of the road inside the barrio up to the point of delivery in the sugar central.


SECTION II.- Any person, firm or corporation violating or assisting in the violation of any provision of this ordinance shall be punished by a fine of not exceeding FIFTY PESOS (P50.00) or an imprisonment of from one (1) to ten (10) days, or both such fine and imprisonment at the discretion of the Court.

SECTION III.- This Ordinance shall take effect upon approval.




