RESOLUTION NO. 187

The Board, on motion of Councilor Cleto P. Evangelista,
seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. VI
AN ORDINANCE TO AMEND ORDINANCE
NO. IV, s. 1954

BE IT ORDAINED by the Municipal Board of Ormoc City
that:

Section 1.- Section 1, Ordinance No. IV, s. 1954,
is hereby amended to read as follows:

"Sec. 1- x x x x x x"

"PROVIDED, THAT, owners of those nipa
houses already existing within the area
aforementioned will be given six (6) months,
from the date of passage of this ordinance,
within which to change their houses of light
materials (bamboo and nipa houses) to houses
of strong materials with galvanized iron
roofings."

"Sec. 1-A.- Any person or persons, firm or
corporation, who violates or assists in
the violation of the provisions of Sec. 1
hereof, shall, upon conviction, be fined
not more than ₱200.00 or an imprisonment
of not more than two (2) months, or both
such fine and imprisonment, at the discre-
tion of the Court."

Section 2.- Let copy of this resolution and ordi-
nance be furnished each to the Hon. City Mayor; City
Treasurer; City Auditor; City Attorney; Municipal Judge;
Chief of Police; City Engineer; Fire Chief; City Health
Officer and the City Agronomist; all of Ormoc City and
copies to be posted in public places, Ormoc City.

CARRIED. 5 in favor, 2 abstention; 1 against.

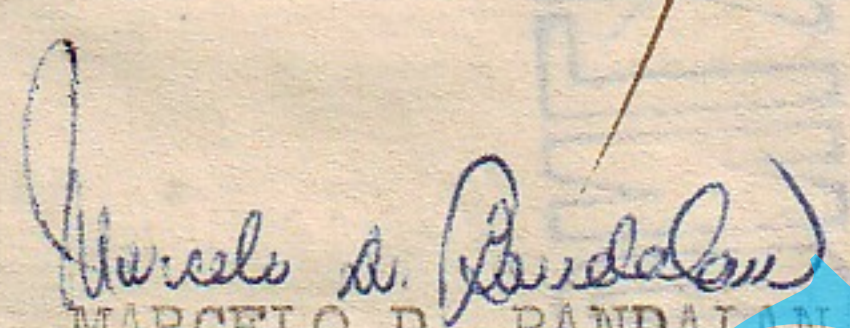
