RESOLUTION NO. 14

WHEREAS, the City Health Officer, Ormoc City, in his letter to this Body dated February 5, 1954, strongly recommended to this Body the construction of six semi-flush type toilets with first class bathrooms in different sections of the city;

WHEREAS, the City of Ormoc is not presently in the situation as to meet the expenses for the construction of six toilets as recommended by the City Health Officer;

WHEREAS, to partly implement said recommendation of the City Health Officer, and considering the imperative need of a public toilet in the public market where the demand of same is more urgent than other sections of the city so as to maintain sanitation in the public market;

NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Cesar Samson;

BE IT RESOLVED, as is hereby resolved, to adopt:

ORDINANCE NO. I

AN ORDINANCE APPROPRIATING THE SUM OF P2,000 TO BE MADE AVAILABLE FOR THE CONSTRUCTION OF A SEMI-FLUSH TYPE TOILET WITH FIRST CLASS BATHROOM IN THE PUBLIC MARKET

BE IT ORDAINED by the Municipal Board of Ormoc City, that:

Section 1. The sum of TWO THOUSAND PESOS (P2,000), or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated, to be made available for the construction of a semi-flush type toilet with first class bathroom in the public market, City of Ormoc;

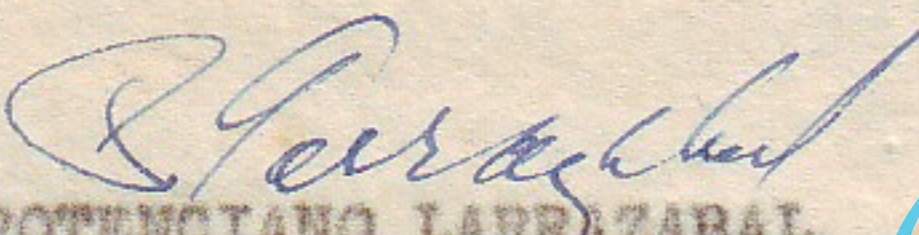
Section 2. This Ordinance shall take effect upon its approval.

CARRIED UNANIMOUSLY.

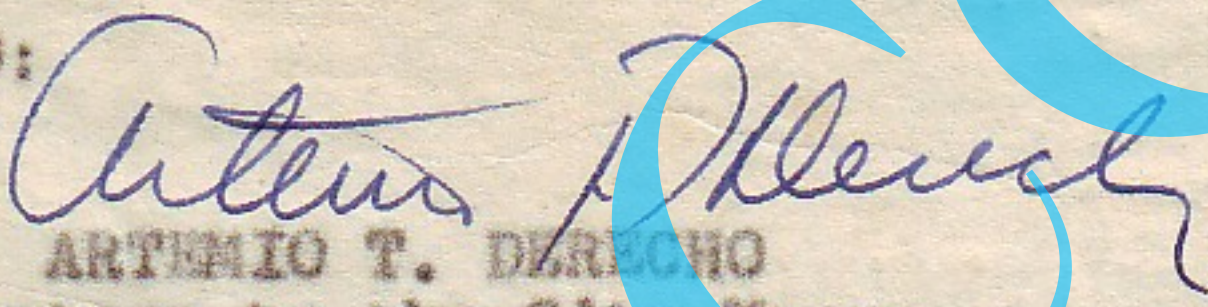
