RESOLUTION NO. 174

"WHEREAS, on July 14, 1956 this Board passed Ordinance No. XII, amending the Building Ordinance, numbered 2, series of 1950, the amendment particularly being that of the second to the last sentence of the first paragraph of Article 2 of said Building Ordinance;

"WHEREAS, this Board has come to understand that there is a sort of misinterpretation on the part of the City Engineer's office in the real sense that the Board wants to convey in passing the aforementioned amendment;

"WHEREAS, in order to clear things out this Body deems it necessary to further amend and simplify said ordinance;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. XIII

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 2, SERIES OF 1950 AS AMENDED BY ORDINANCE NO. XII, SERIES OF 1956.

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, that:

SECTION 1. The first paragraph of Ordinance No. 2, series of 1950, as amended by Ordinance No. XII, series of 1956, is hereby amended further to read as follows:

ARTICLE 2 - PLANS AND SPECIFICATIONS

"A complete set of plans consisting of (a) location plan showing the site and location of the lot and the exact location of the structure or building to be constructed; (b) floor and floor framing plans for every floor including the basement; (c) roof and roof framing plans; (d) at least two elevation plans; (e) at least one longitudinal plan; (f) at least one cross sectional plan; (g) a complete plumbing installation plan; and (h) a complete electrical installation plan; and other cross sectional plans as the City Engineer may deem necessary, shall be submitted by the owner or applicant to the Office of the City Engineer for approval prior to starting (the) work on any structure or building the cost of which

is ₱10,000 or more. All the above-mentioned plans must be properly signed by a licensed civil engineer, or architect. For structures or buildings the cost of which is less than ₱1,000.00 a complete sketch shall be required. The plans of structures or buildings the estimated costs of which are less than ₱10,000 shall be signed by any private experienced carpenter, at the discretion of the owner. Three copies of each set of plans or sketches shall accompany all applications for building permit."

SECTION 2. This Ordinance shall take effect immediately upon approval by the Honorable City Mayor of Ormoc.


