"WHEREAS, in a letter to this Body dated November 6, 1956, the City Treasurer, Ormoc City, strongly recommended the enactment of an ordinance, levying an additional tax of not exceeding 25% of the rates fixed in Sections 142 and 145 of the National Internal Revenue Code as amended by Republic Act No. 1435, on manufactured oils sold or distributed within the limits of the city:

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. Paragraph (a) of Section 2, Ordinance No. 9, series of 1948, is hereby amended to read as follows:
