ORDINANCE NO. III

AN ORDINANCE FIXING AND REGULATING THE MANNER
OF PAYING LICENSES FOR THE OPERATION OF
COCKPITS IN THE CITY OF ORMOC

BE IT ORDAINED by the Municipal Board of Ormoc
City, that:

SECTION 1. Every person, firm, company or corpora-
tion who shall establish, operate or maintain a cockpit
in the City of Ormoc shall pay to the city treasury a
quarterly license fee which shall be determined as follows:

For cockpits established, operated or maintained within
the poblacion..... P150.00 per quarter

For cockpits established, operated or maintained in the
barrios along the national highway and within a distance
of 5 kilometers from the poblacion..P100 per quarter.

For cockpits established, operated or maintained in the
barrios of Macabug, Ipil and Valencia..P100 per quarter.

For cockpits established, operated or maintained in all
other barrios not specified above...P50.00 per quarter.

SECTION 2. All licenses for the establishment,
operation and maintenance of cockpits shall be due and
paid in full to the city treasurer within the first
fifteen (15) days at the beginning of every quarter.

SECTION 3. No person, firm, company or corporation
shall establish, operate, maintain or cause to be es-
tablished, operated or maintained, a cockpit without
first paying the necessary license fees.

SECTION 4. Any person, firm, company or corporation
found violating the provisions of this Ordinance shall be
punished by a fine of not more than Two Hundred Pesos
(P200.00) and in the case of a firm, company or corpora-
tion the manager or president thereof, as the case may be,
shall be the one responsible.

SECTION 5. Any Ordinance or parts thereof incon-

sistent herewith, are hereby repealed or modified accordingly.

SECTION. 6. This Ordinance shall take effect upon approval of the Honorable City Mayor.




