RESOLUTION NO. 98

"WHEREAS, it has been noted by this Body that private firms and private persons have been converting the public tennis court of Ormoc City into a drying place for palay, corn, nets and other products and things;

"WHEREAS, for the interest of the public in general this Body deems it not wise to allow anybody to dry anything on said tennis court so as not to hinder or obstruct the playing of ball games for which same has been intended for;

NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. VI - AN ORDINANCE PROHIBITING THE DRYING OF PALAY, COPRA, NETS, CORN, ASPHALT, CLOTHES OR ANYTHING, AT THE PLAZA TENNIS COURT OF ORMOC CITY, AND PROVIDING PENALTY FOR THE VIOLATION THEREOF

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. No person, firm, company or corporation is allowed to dry palay, copra, corn, nets, asphalt, clothes or anything, at the plaza tennis court of Ormoc City; and

SECTION 2. Any person, firm, company or corporation found violating the provisions of this Ordinance shall, upon conviction, be punished by a fine of not more than ₱100 or an imprisonment of not less than 10 days but not more than one month, or both fine and imprisonment at the discretion of the court;

SECTION 3. Any ordinance or parts thereof inconsistent herewith, are hereby repealed.

SECTION 4. This Ordinance shall take effect upon approval of the City Mayor.
