RESOLUTION NO. 102

The Board, on motion of Councilor Cesar Samson,
seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to
adopt:

ORDINANCE NO. VII

AN ORDINANCE AMENDING CERTAIN SECTIONS AND PORTIONS
OF ORDINANCE NO. 16, SERIES OF 1948

BE IT ORDAINED by the Municipal Board of Ormoc
City, that:

SECTION 1. A new section, to be known as Section
1-A is hereby inserted between sections 1 and 2 of Ordinance
No. 16, series of 1948 to read as follows:

"SECTION 1-A. Fish vendors.- There shall be levied
and collected from each person, firm, company or corporation engaged in the business of fish and its kind,
immediately upon arrival at Ormoc City, the amount
equal to the rate mentioned in Section 2 of this Ordinance."

SECTION 2. A new section, to be known as Section
2-A is hereby inserted between sections 2 and 3 of
Ordinance No. 16, series of 1948 to read as follows:

"SECTION 2-A. There shall be levied and collected
from each person, firm, company or corporation who
brings into Ormoc City any of the animals mentioned
hereunder the amount specified opposite each/ of animal
as follows:

Carabao, buffalo or cow	₱ 1.00 per head
Horse	1.00 " "
Goat or sheep25 " "
Hogs50 " "
Chickens60 per dozen

PROVIDED, HOWEVER, that these fees shall be imposed
only upon the animals mentioned herein if they are
brought in for sale or for business purposes ; AND
for the slaughter of any of the animals mentioned
above there shall be levied and collected, whether
slaughtered outside or inside the market premises for
business purposes, the amount equal to the rate mentioned
in Section 2 hereof."


SECTION 3. This amendment shall take effect immediately upon its approval by the Honorable City Mayor of Ormoc.


