RESOLUTION NO. 3

The Board, on motion of Councilor Alvaro I.
Gutierrez, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to
adopt:

ORDINANCE NO. 1

AN ORDINANCE IMPOSING A CHARGE OF FIVE CENTAVOS
(P0.05) PER PERSON TAKING A BATH IN THE
PUBLIC BATH OF THE PUBLIC TOILET IN THE
MARKET PREMISES, ORMOC CITY.

BE IT ORDAINED by the Municipal Board of Ormoc
City, That:

SECTION 1. There shall be charged and collected
by the City Treasurer of Ormoc City or his authorized
representative, from every person who takes a bath in
the bathroom of the public toilet in the market prem-
ises, Five Centavos (P0.05), payable before the person
or individual is being admitted to use the public bath.
The City Treasurer or his authorized representative
may use or issue cash tickets for the purpose.

SECTION 2. All funds derived from the collection
above stated shall accrue to a special fund which
shall be used for the maintenance of sanitation of
the same public bath and its adjoining toilets.

SECTION 3. This Ordinance takes effect immedi-
ately upon approval by the City Mayor of Ormoc.

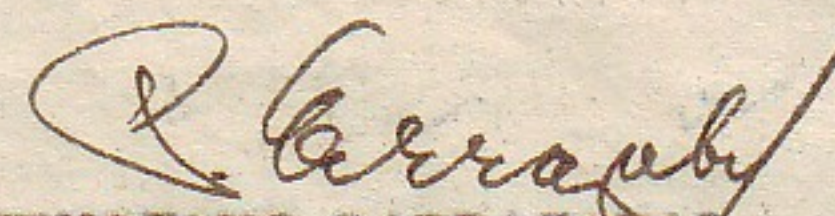

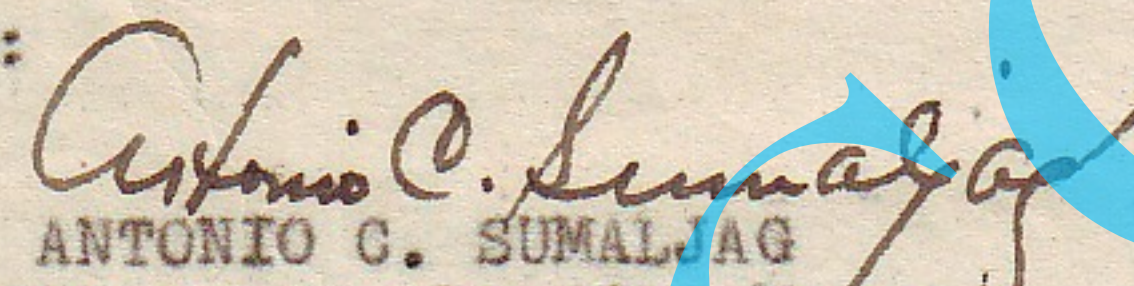
