RESOLUTION NO. 105

"WHEREAS, this Board passed Resolution No. 174 adopting Ordinance No. XIII, s. 1956, further amending Ordinance No. 2, s. 1950 as amended by Ordinance No. XII, s. 1956, on September 22, 1956;

"WHEREAS, through the insistence of former Asst. Civil Engineer Adventor Fernandez of Ormoc City, who in his letter to this Body dated September 28, 1956 requested that said Ordinance No. XIII, s. 1956 be amended to the effect that "the plans of all buildings costing more than One Thousand Pesos (\$1,000.00) shall be prepared or signed and sealed by a licensed Civil Engineer and/or licensed Architect" and citing as the basis of his request Section 23 of Republic Act 544, otherwise known as the Civil Engineering Law, the Director of Public Works in a 5th indorsement dated December 11, 1956, requested the amendment of Ordinance No. XIII, s. 1956 "in view of the reasons contained in the attached letter of the City Engineer, Ormoc City,x x x"; and

WHEREAS, this Board, acting on the request of the Director of Public Works, and in order not to violate the spirit and purpose of the provisions of Section 23 of Republic Act 544, deems it proper to amend the aforecited Ordinance in question.

"NOW, THEREFORE, the Board, on motion of Councilor Cesar Samson, seconded by Councilor Guillermo T. Parrilla;

"BE IT RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 2 AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 2, SERIES OF 1950,

AS AMENDED BY ORDINANCE NOS. XII & XIII, BOTH SERIES OF 1956.

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. There shall be inserted between the last paragraph under title ARTICLE 2 and title ARTICLE 3, of Ordinance No. 2, series 1950, as amended by by Ordinance Nos. XII & XIII, both series of 1956, a new paragraph to read as follows:

- Page 2 -(RESOLUTION NO. 105, EMBODYING ORDINANCE NO. 2, SERIES OF 1957 - MUNICIPAL BOARD, ORMOG CITY) "However, if the buildings to be constructed are intended for public gatherings like theaters, cinematographs, stadia, churches or structures of like nature, as enumerated in Section 23 of the Engineering Law, the plans and specifications thereof should be prepared and signed by an architect or a licesned civil engineer, even if the appropriation of that building is \$1,000.00 or less." SECTION 2. This Ordinance shall take effect as of July 1, 1957. Enacted, June 8, 1957. Approved, June 27, 1957. "RESOLVED FINALLY, to furnish copies of this Resolution-Ordinance each to the Honorable Executive Secretary, Malacanang, Manila; the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer, the City Attorney and the Municipal Judge, all of Ormoc City.
