VORDINANCE NO. 4

AN ORDINANCE REGULATING THE SHIPMENT OF CARABAOS OUTSIDE THE JURISDICTION OF ORMOC CITY AND PROVIDING PENALTIES FOR ITS VIOLATION AND FOR OTHER PURPOSES

Be it enacted by the Municipal Board of Ormoc City, Philippines, that:

SECTION 1. No person or group of persons shall ship an aggregate total of more than twenty-five (25) heads of carabaos, each week, outside the jurisdiction of Ormoc City, for commercial or slaughter purposes;

SECTION 2. Any person who deisres to ship carabaos for commercial or slaughter purposes shall make his application in writing and in such forms as may be prescribed, ten (10) days before date of shipment, to the City Mayor;

SECTION 3. Any person who desires to ship carabaos, for purposes other than commercial or slaughter, shall, aside making his application for shipment, execute a sworn statement, stating among others, that said carabao shipped is not to be disposed of, conveyed or slaughtered within six (6) months from the date of shipment;

SECTION 4. The City Mayor shall determine the number of carabas to be alloted to each person or group of persons to be shipped per week, but in no case shall it exceed the aggregate total number mentioned in Section 1 hereof;

SECTION 5. This ordinance shall be without prejudice to other requirements necessary for the shipment of carabaos;

SECTION 6. The term used in this ordinance shall mean:

"Commercial" - pertaining to trade or commerce; mercantile;

"Slaughter" - to kill for market or consumption;

"Person" or "group of persons" - association, company, corporation and partnership as well as natural persons;

"Week" - seven (7) calendar days;

"Ship" or "shipment" - shipping or sending out of the jurisdiction of Ormoc City by any means of transportation, such as by land, sea air or by foot;

SECTION 7. Any violation of any provision of this ordinance shall be punished by a fine of not less than \$\mathbb{P}\$50.00 nor more than \$\mathbb{P}\$200.00 or by imprisonment of not more than one month, or both fine and imprisonment in the discretion of the Court. If the offender is a partnership, corporation, company or association, the criminal liability shall devolve upon its president, director or any other official of said organization, responsible for the violation;

SECTION 8. Any ordinance or parts thereof inconsistent with this ordinance or parts hereof, are hereby repealed or modified accordingly;

SECTION 9. This ordinance shall take effect fifteen (15) days after approval.
