RESOLUTION NO. 187

"WHEREAS, it has come to the attention of the Board that there are at present bicycles with carriers (tricycles) operating for hire in the city; and

"WHEREAS, the City Treasurer in a letter to this Board dated November 21, 1958, has recommended the imposition of a city license tax for the operation of these "common carriers" as this is a kind of business which can be taxed under the powers of this Board pursuant to the provisions of the Charter of Ormoc City;

"NOW, THEREFORE, the Board, on motion of Councillor Ocubillo, seconded by Councillor Parrilla;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 7

AN ORDINANCE AMENDING ORDINANCE NO. 1, SERIES 1949; ENTITLED "AN ORDINANCE IMPOSING LICENSE TAXES UPON PERSONS, COMPANIES, FIRMS OR CORPORATIONS ENGAGED IN VARIOUS BUSINESSES AND PROVIDING PENALTY FOR VIOLATION THEREOF AND OTHER PURPOSES."

BE IT ORDAINED by the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, That:

SECTION 1. Section 1 of Ordinance No. 1, series of 1949, is hereby amended by inserting a new schedule between schedules A-127 and A-128 to be known as Schedule A-127-A to read as follows:

Schedule	Kind of business	Annual Tax
A-127-A	- Bicycle with carrier (Tricycle) for hire...	P 8.00

SECTION 2. This ordinance takes effect immediately upon approval by the Honorable City Mayor of Ormoc.

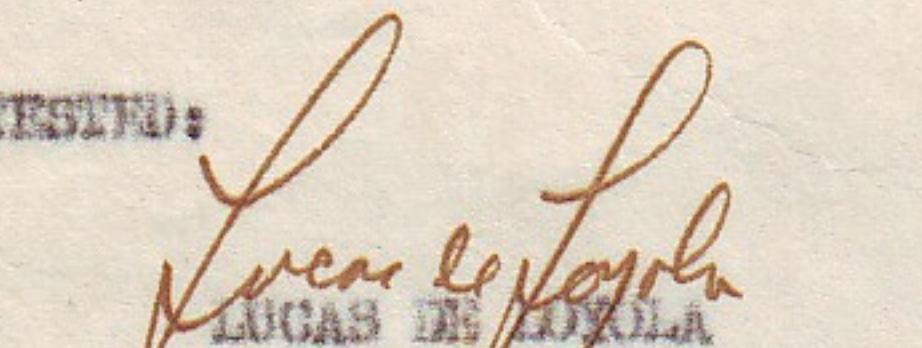
