"RESOLVED, as it is hereby resolved, to adopt:
ORDINANCE NO. 1

(s. 1959)

AN ORDINANCE AMENDING ORDINANCE NO. 5, SERIES OF 1951, ENTITLED "AN ORDINANCE SETTING RULES AND REGULATIONS ON THE OCCUPA-TION OF MARKET STALLS AND IMPOSING PENALTIES THEREFOR."

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Section 2 of Ordinance No. 5, series of 1951, is hereby amended by inserting between subsection (c) and Section3 thereof, a new subsection to Section 2 to be known as subsection (d) to read as follows:

(d) The two billiard operators, Mr. Pablo Ablen and Mr. Francisco Manawatao may be allowed to operate the billiard tables they are now operating until December 31, 1959; Provided, that during this period that they are allowed to remain and operate their billiard tables in the public market, they should operate the said tables personally and not to convey or transfer the operation of same to third parties; Provided further, that after December 31, 1959 they should transfer their billiard tables to some other place outside the market premises; and, Provided finally, that no other third parties may be allowed to operate billiard tables hereafter in the public market premises, except the two already mentioned who are allowed to stay within the public market premises until Bacember 31, 1959;

SECTION 2. This Ordinance takes effect as of the 1st day of June, 1959.
