RESOLUTION NO. 205

"WHEREAS, sub-paragraph (a), Section 1, of Ordinance No. XV, series of 1956, of this Board, fixed the license fees of cockpits established, operated or maintained in the City of Ormoc;

WHEREAS, among others, said sub-paragraph (a), Section 1, of Ordinance No. XV, series of 1956, reads:

"(a) There shall be paid in advance to the City Treasurer of the City of Ormoc for every license granted a quarterly license fee which shall be determined as follows:

For cockpits established, operated or maintained

1. Within the poblacion, \$150 per quarter;

2. In barrios along the national highway and within a distance of 5 kilometers from the poblacion, \$100 per quarter;

3. In Macabug, Ipil and Valencia, \$100 per

quarter; (#)

4. In all other barrios not herein specified, \$750 per quarter."

(NOTE: (#) - amended by Res. No. 137, c.s., to delete Macabug from item 3.)

"WHEREAS, in accordance with item 3 above, Valencia is among those rated at \$100 per quarter;

WHEREAS, conditions have already changed since the adoption of the aforesaid ordinance such that the income of the cockpit now in operation in Valencia has considerably reduced during the last few years rendering it incapable of paying the quarterly license fee of \$100.00 any further; and

WHEREAS, themanagement of the Valencia cockpit has requested the reduction of the quarterly license fee from \$100 to \$75, which this Body also deems reasonable;

"NOW, THEREFORE, the Board, on motion of Councilor Aviles, seconded by Councilor Pongos;

- Page 2 -(RESOLUTION NO. 205, adopting ORDINANCE NO. 11, SERIES OF 1960 - MUNICIPAL BOARD, ORMOC CITY) "RESOLVED, as it is hereby resolved, to adopt: ORDINANCE NO. 11 AN ORDINANCE FURTHER AMENDING ORDINANCE NO. XV, SERIES OF 1956, ENTITLED "AN ORDINANCE REGULATING THE ESTABLISHMENT AND MAINTENANCE OF COCKPITS IN ORMOC CITY." BE IT ORDAINED by authority of the Municipal Board of Ormoc City, pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, That: SECTION 1. Item 3 under sub-paragraph (a), Section 1 of Ordinance No. XV, series of 1956, is hereby amended further, to delete the word "Valencia" from said item. SECTION 2. A new item, to be known as item 3-a, is hereby inserted between items 3 and 4 of sub-paragraph (a), Section 1 of Ordinance No. IV, series of 1956, to read as follows: "3-a. In Valencia, 775.00 per quarter." SECTION 3. This Ordinance shall take effect during the last quarter of the calendar year 1960. ENACTED, October 21, 1960. APPROVED "RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Attorney, the Municipal Judge, the Chief of Police, and the Barrio Lieutenant of Valencia, all of Ormoc City "CARRIED, Unanimously."
