RESOLUTION NO. 128

"WHEREAS, the inspectors of the PHILCOA have complained of the poor quality of copra produced in Ormoc City;

"WHEREAS, according to said Philcoa inspectors, copra produced here is dried on bare soil thus allowing dirt and mud to accumulate on the meat and causing a dark or blackened appearance of the product;

"WHEREAS, in view of the poor quality of said product, our copra produced in Ormoc can not command a good price in the market;

"NOW, THEREFORE, the Board, on motion of Councilor Aviles, seconded by Councilor Abas, with the aim in view of producing good-quality copra in Ormoc City;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 3

AN ORDINANCE PROHIBITING THE DRYING OF COPRA ON BARE SOIL WITHOUT USING ANY MAT, SAWALI, CANVAS, EMPTY SACKS, OR ANY OTHER LAYER.

Be it ordained by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, That:

SECTION 1. It shall be unlawful for any person or group of persons to dry copra on bare soil without using any mat, sawali, canvas, empty sacks, or any other layer wherein said copra is dried.

SECTION 2. Any person or group of persons who shall violate any provision of this Ordinance shall be punished by a fine of not exceeding P50.00 but in no case less than P10.00, or an imprisonment of not more than five days, or both such fine and imprisonment at the discretion of the Court.

SECTION 3. This Ordinance shall take effect immediately upon approval.

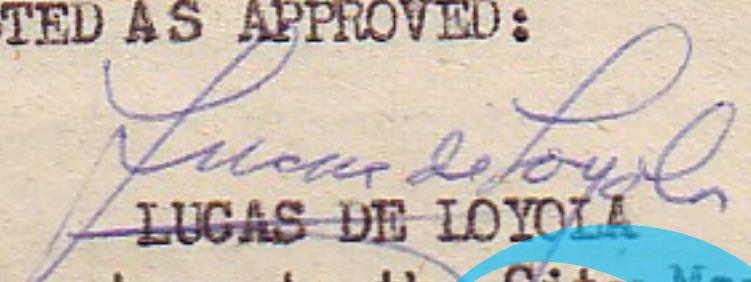
