RESOLUTION NO. 137

"WHEREAS, sub-paragraph (a), Section 1, of Ordinance No. XV, series of 1956, of this Board, fixed the license fees of cockpits established, operated or maintained in the City of Ormoc;

"WHEREAS, among others, said sub-paragraph (a), Section 1, of Ordinance No. XV, series of 1956, reads:

"(a) There shall be paid in advance to the City Treasurer of the City of Ormoc for every license granted a quarterly license fee which shall be determined as follows:

For cockpits established, operated or maintained

1. Within the poblacion, ₱150 per quarter;
2. In barrios along the national highway and within a distance of 5 kilometers from the poblacion, ₱100 per quarter;
3. In Macabug, Ipil and Valencia, ₱100 per quarter;
4. In all other barrios not herein specified, ₱50 per quarter. "

"WHEREAS, item 3 above specifies three barrios, namely, Macabug, Ipil and Valencia, as those rated at ₱100 per quarter;

"WHEREAS, there's no denying the fact that Macabug can not be compared to the two other barrios, Ipil and Valencia, both in population and size; and

"WHEREAS, it would therefore be unfair if a cockpit in Macabug with much lesser income, be made to pay the same license fee as that established in either Ipil or Valencia;

"NOW, THEREFORE, the Board, on motion of Councilor Pongos, seconded by Councilor Abas;

"RESOLVED, as it is hereby resolved, to adopt:

AN ORDINANCE AMENDING ORDINANCE NO. XV, SERIES of 1956, ENTITLED  
"AN ORDINANCE REGULATING THE ESTABLISHMENT AND MAINTENANCE OF  
COCKPITS IN ORMOC CITY."

Be it ORDAINED by authority of the Municipal Board of Ormoc City, pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, That:

SECTION 1. Item 3 under sub-paragraph (a), Section 1 of Ordinance No. XV, series of 1956, is hereby amended to delete the word "Macabug" such that said item should read as follows:

"3. In Ipil and Valencia, P100 per quarter;"

SECTION 2. This Ordinance shall take effect immediately upon approval.
