## RESOLUTION NO. 149

WHEREAS, Ordinance No. 1, s. 1959, limited the stay of the billiard tables operated by Mr. Pablo Ablen and Mr. Francisco Manawatao in the public market until December 31, 1959; and

"MESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 5
AN ORDINANCE AMENDING ORDINANCE NO. 1, SERIES OF 1959, ENTITLED
"AN ORDINANCE AMENDING ORDINANCE NO. 5, SERIES OF 1951,
ENTITLED 'AN ORDINANCE SETTING RULES AND REGULATIONS ON
THE OCCUPATION OF MARKET STALLS AND IMPOSING PENALTIES
THEREFOR."

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Subsection (d) under Section 2 of Ordinance No. 5, s. 1951, as amended by Ordinance No. 1, s. 1952, is hereby further amended to read as follows:

(d) Mr. Francisco Manawatao, a billiard operator in the public market, may be allowed to operate his billiard table he is now operating, until December 31, 1960; Provided, that during this period that he is allowed to remain and operate his billiard table in the public market, he shall operate the said table personally and not to convey or transfer the operation of same to third parties; Provided further, that after December 31, 1960 he shall transfer his billiard table to some other place outside the market premises; and Provided finally, that no other person or persons may be allowed to operate billiard tables hereafter in the public market premises, except the person mentioned above, who is allowed to stay until December 31, 1960.

SECTION 2. This Ordinance shall take effect immediately upon approval.
