RESOLUTION NO. 161

"WHEREAS, the Market Superintendent recommended to this Board the charging of a fee for the use of fish stalls (pasungan) in the public market of P.20 per square meter per day;

"WHEREAS, according to the Market Superintendent, this kind of fee has already been imposed in the markets of such cities as Cebu, Davao, Tacloban and others; and

"WHEREAS, considering that the fee recommended for collection is nominal and reasonable;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Aviles;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 7

AN ORDINANCE AMENDING ORDINANCE NO. 16, SERIES OF 1948, BY INSERTING THEREON A NEW SECTION PROVIDING FOR THE LEVY OF A FEE OF P0.20 PER SQUARE METER FOR THE USE OF THE FISH STALLS IN THE PUBLIC MARKET.

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Ordinance No. 16, series of 1948, is hereby amended by inserting a new section between Sections 2 and 3 and to be designated as Section 2-B, providing for the levy of a fee of P0.20 per square meter of the fish stalls in the public market, to read as follows:

"SECTION 2-B. There shall be levied and collected from each person occupying or using the fish stalls (pasungan) in the public market a fee of P0.20 per square meter per day; provided however, that any change in occupancy of said stall during the day shall subject the new occupant to the same fee of P0.20 per square meter."

SECTION 2. Any ordinance or portions thereof inconsistent with this ordinance, are hereby repealed or modified accordingly.


SECTION 3. This ordinance shall take effect immediately upon approval.




