RESOLUTION NO. 12

"WHEREAS, sub-paragraph (a), Section 1, of Ordinance No. XV, series of 1956, of this Board, fixed the license fee of cockpits established, operated or maintained in the City of Ormoc;

"WHEREAS, among others, said sub-paragraph (a), Section 1, of Ordinance No. XV, series of 1956, reads:

"(a) There shall be paid in advance to the Treasurer of Ormoc City for every license granted a quarterly license fee which shall be determined as follows:

For cockpits established, operated or maintained

1. Within the poblacion, P150 per quarter;
2. In barrios along the national highway and within a distance of 5 kilometers from the poblacion, P100 per quarter;
3. In Macabug, Ipil and Valencia, P100 per quarter; (*)
4. In all other barrios not herein specified, P50 per quarter."

(NOTE: (*) - amended by Res. No. 12 to delete Macabug by Res. No. 205 reducing the fee to P75.00 per quarter.

"WHEREAS, in accordance with item 3 of the foregoing resolution, the license fee for cockpits in Macabug, Ipil and Valencia is P100 per quarter;

"WHEREAS, conditions have already arisen under the foregoing ordinance such that the people of Macabug, Ipil and Valencia are unable to pay the license fee of P100 per quarter and it is hereby resolved that the license fee for cockpits in Macabug, Ipil and Valencia be reduced to P75.00 per quarter;

AND IT ORDAINED by authority of the Municipal Board of Ormoc

SECTION 1. Item 3 under sub-paragraph (a), Section 1 of
Ordinance No. XV, series of 1956, is hereby amended further, to
read as follows:

"3. In Ipil, P50 per quarter;"

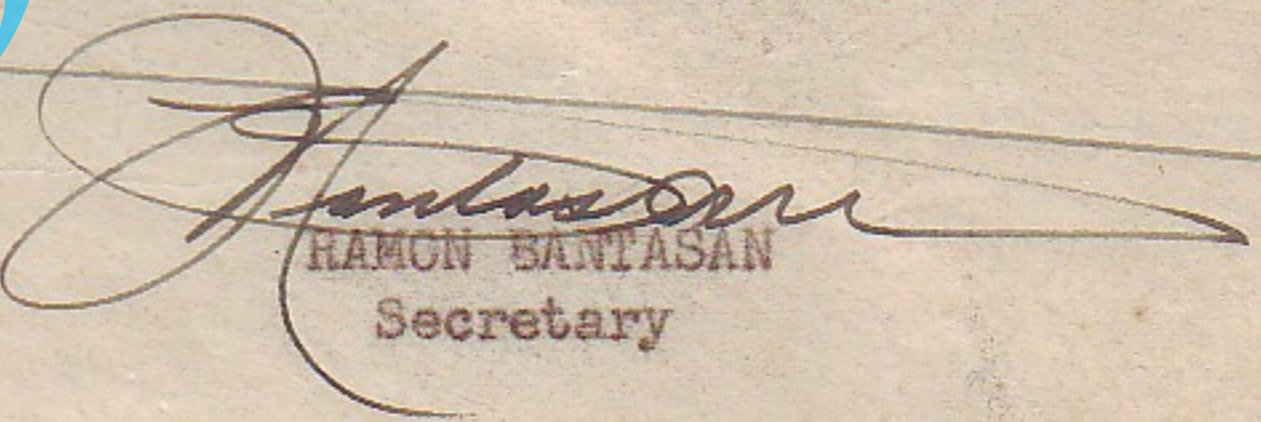
SECTION 2. This ordinance shall take effect immediately upon
approval.

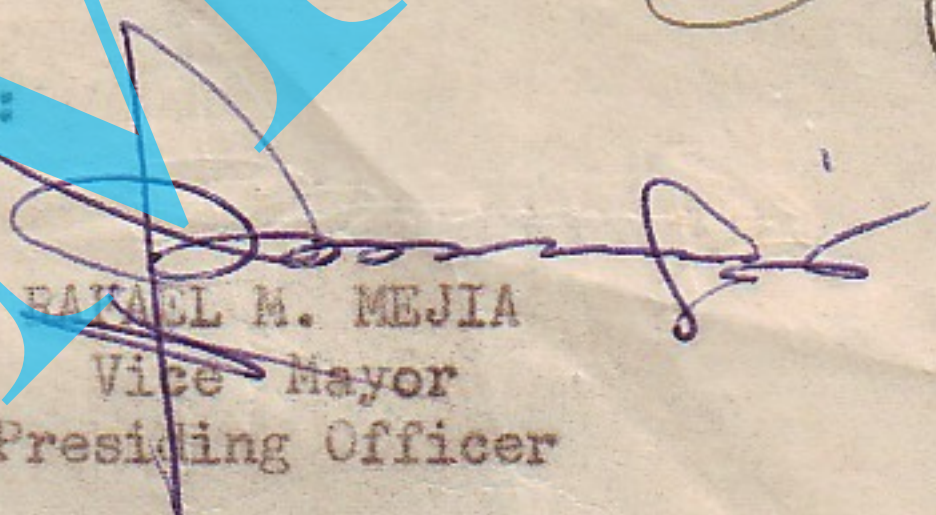

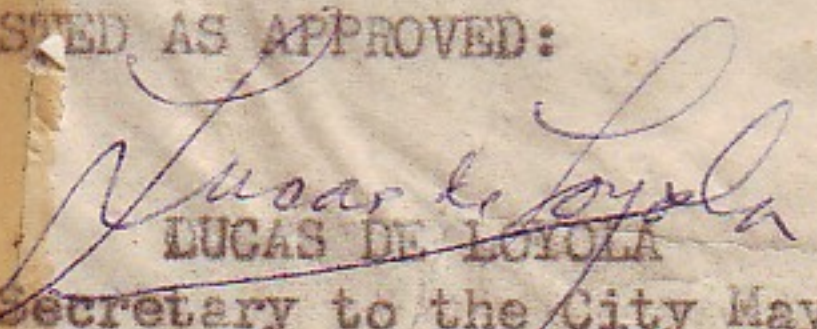

Gentlemen:

I am herewith returning to you Resolution No. 12, current series, of that Honorable Body with my VETO thereof, for the following reasons:

1.- Within Resolution No. 12 partakes of the nature of a class legislation by prescribing a different rate of quarterly license fee for the operation and maintenance of cockpits for Barrio Ipil, at P50, as against that of Barrio Valencia previously fixed by amendment of Ordinance XV s-56, at P75; and

2.- Considering that both barrios Ipil and Valencia are along the national highway, heavily populated, and located at a distance of more than five kilometers from the poblacion, within Resolution No. 12, perforce, violates one of the essentials of an ordinance - the principle of universal application.
