RESOLUTION NO. 243

"WHEREAS, due to inadvertence this Body failed to include in the current annual budget, the position of Janitor-Watchman in the slaughterhouse which this Board has created by Resolution No. 212, series of 1960, and now filled by Mr. Publeo Ariño;

"WHEREAS, the Offices of the City Treasurer and City Auditor also reported omissions in the budget, viz:

Office of the City Treasurer:

The position of one campaign clerk had been inadvertently reduced in salary from ₱1,260.00 to ₱1,200.00 per annum;

Office of the City Auditor:

The positions of two Clerk-Checkers payable from projects in which engaged, have been also omitted; and

"WHEREAS, it becomes necessary that the foregoing omissions be inserted in the budget in order to maintain efficiency in the public service;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Conopio and Ocubillo;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 10

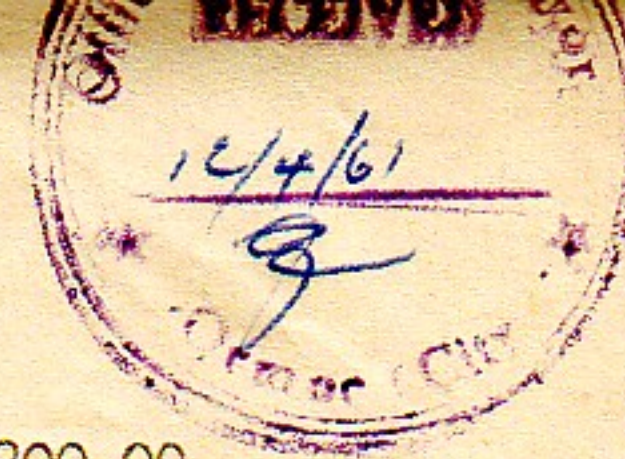
AN ORDINANCE AMENDING ORDINANCE NO. 8 (1961-1962 CITY BUDGET),
CURRENT SERIES

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Section 1 of Ordinance No. 8, current series (1961-1962 City Budget), is hereby amended in the manner provided for hereunder as follows:

Under the Office of the City Treasurer, the compensation of the first item of Campaign Clerk should be ₱1,260.00 and should therefore read:

"One : Campaign Clerk ₱1,260.00"



instead of: One : Campaign Clerk ₱1,200.00.

Under the Agricultural and Livestock Inspection, the following item should be inserted between the positions of Two Meat Inspectors and One Skilled Laborer-Watchman for the Nursery:

"One : Janitor-Watchman for the Slaughterhouse
(from ₱1,020.00) at ₱1,200.00 per annum,
effective October 16, 1961 ₱1,147.50"

Under the Office of the City Auditor the following positions should be included:

"One Clerk-Checker at ₱6.00 per day payable
from projects in which engaged.

"One Clerk-Checker at ₱5.50 per day payable
from projects in which engaged."


SECTION 2. EFFECTIVITY. The effectivity of this ordinance should follow the effectivity of Ordinance No. 8 subject of this amendment, i.e., July 1st, 1961, except where otherwise provided.

"RESOLVED FURTHER, that the sum of ₱1,207.50 or so much thereof as may be necessary, be appropriated from out of any funds existing in the city treasury not otherwise appropriated, to carry out the provisions of this ordinance;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the City Veterinarian, all of Ormoc City.

"CARRIED, Unanimously."




