RESOLUTION NO. 249-A

"WHEREAS, the City Attorney made representations with this Body requesting for additional personnel in his office;

"WHEREAS, this Body considering the volume of work handled by the Office of the City Attorney, sees the necessity of employing more personnel in said office;

"WHEREAS, another office that needs additional personnel is the Municipal Court, to take charge of dispatching its mails and such other services pertaining to that of a messenger-janitor;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Conopio and Ocubillo;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 11-A

AN ORDINANCE CREATING THE POSITIONS OF FILING CLERK AND MESSENGER-JANITOR IN THE OFFICE OF THE CITY ATTORNEY AND MESSENGER-JANITOR IN THE OFFICE OF THE MUNICIPAL COURT.

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The positions of Filing Clerk and Messenger-Janitor are hereby created in the Office of the City Attorney, Ormoc City, with compensation at the rate of ₱1,200.00 per annum, each.

SECTION 2. Another position of Messenger-Janitor is likewise hereby created in the Office of the Municipal Court, Ormoc City, with compensation at the rate of ₱1,200.00 per annum.

SECTION 3. The sum of One Thousand Eight-Hundred Pesos (₱1,800.00) is hereby appropriated from out of any funds existing in the city treasury not otherwise appropriated, to cover the salaries of these positions from January 1, 1962 to June 30, 1962.

SECTION 4. This ordinance shall take effect on January 1, 1962.


"RESOLVED FINALLY, to furnish copies of this resolution-ordinance, each to the City Treasurer, the City Auditor, the City




Attorney and the Municipal Judge, all of Ormoc City.
