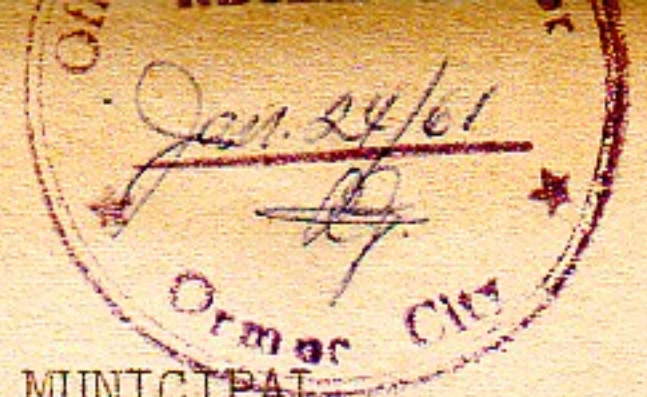

RESOLUTION NO. 16

"WHEREAS, Councilor Aviles manifested before the Board that the Honorable City Mayor is desirous of appointing two additional confidential agents in the persons of Mr. Guillermo Codilla of barrio Valencia and Mr. Floro Pepito;

"WHEREAS, this Body understands that these persons were not yet appointed for lack funds; and

"WHEREAS, in the current annual budget under the Office of the City Engineer, there is an item "Outlay for leave credits" in the amount of ₱575.00, a part of which may be reverted to the Discretionary Fund of the City for the salary of these two additional confidential agents at ₱50.00 per month for three months;

"NOW, THEREFORE, the Board, on motion of Councilor Aviles, seconded by Councilors Parrilla and Omega;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 2

AN ORDINANCE AMENDING RESOLUTION NO. 194 EMBODYING ORDINANCE NO. 10, SERIES OF 1960 (CITY BUDGET, FY 1960-61).

BE IT ORDAINED by authority of the Municipal Board of Ormoc City, pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The item "Outlay for leave credits.....₱575.00" under Contingent Expenses of the Office of the City Engineer as appearing in the city budget for the fiscal year 1960-61 (Ordinance No. 10 as adopted by Resolution No. 194, s. 1960), is hereby amended to read as follows:

"Outlay for leave credits ..... ₱275.00"

SECTION 2. The item "Discretionary Fund" under the Office of the City Mayor in the same budget mentioned in Section 1 hereof, is hereby amended as follows:

"Discretionary Fund ..... ₱6,300.00"

or increased by ₱300.00 - the amount deducted from the item mentioned in Section 1 hereof.



SECTION 3. This Ordinance shall take effect immediately upon approval.


"RESOLVED FINALLY, to furnish copies of this resolution-ordinance each to the City Treasurer and the City Auditor, both of Ormoc City.


