RESOLUTION NO. 71

"WHEREAS, the 1961 plate denomination for motor vehicles have been changed, especially those of public utility vehicles;

"WHEREAS, this Body, in Ordinance No. 6, s. 1950 and No. VIII, s. 1953, has specified in referring to public utility vehicles, "TPU trucks" as those which are not allowed to enter the pier to load cargoes or passengers; and

"WHEREAS, the designation or denomination "TPU truck" is already more or less obsolete in view of the changing of "TPU" to "PUB" or "PUJ";

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Pongos;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 3

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. 6, SERIES OF 1950 AS AMENDED BY ORDINANCE NO. VIII, SERIES OF 1953

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. Section 1 of sub-section "d" of Ordinance No. 6, series of 1950 as amended by Ordinance No. VIII, series of 1953, is hereby amended further such that wherever in said section the designation or denomination "TPU" is found, the same shall be construed to mean "PU-B and PU-J" (Public Utility Bus and Public Utility Jeep).

SECTION 2. This ordinance shall take effect immediately upon approval.






