annum, effective February 1, 1962 ₱ 500.00"

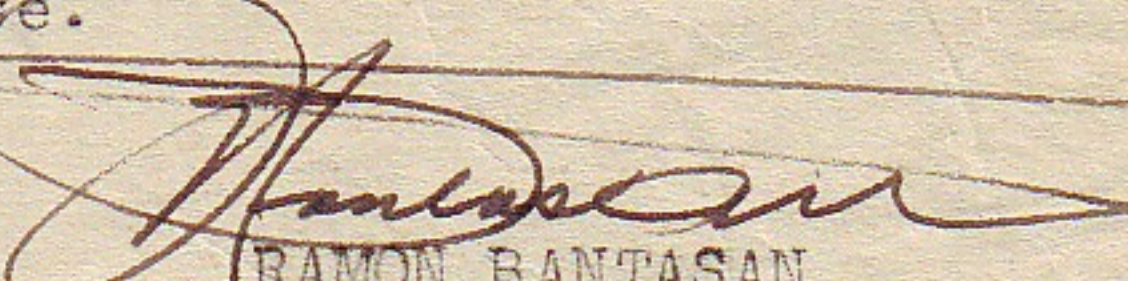
SECTION 2. This ordinance shall take effect as of
