RESOLUTION NO. 51

"WHEREAS, to insure better efficiency of service in the public market this Body has considered the urgent necessity of creating the position of Market Inspector in the Office of City Treasurer separate and distinct from the Market Superintendent;

"NOW, THEREFORE, the Board, on motion of Councilor Tetimo P. Ocubillo, pending since February 2, 1962, seconded by Councilor Francisco D. Abas;

"RESOLVED, as it is hereby resolved, to adopt:

ORDINANCE NO. 2

AN ORDINANCE CREATING THE POSITION OF MARKET INSPECTOR IN THE OFFICE OF THE CITY TREASURER WITH HIS POWERS AND DUTIES AND PROVIDING FUNDS FOR SALARY THEREOF.

BE IT ORDAINED by authority of the Municipal Board of Ormoc City pursuant to the provisions of Republic Act No. 179 as amended by Republic Act No. 429, That:

SECTION 1. The position of Market Inspector in the Office of the City Treasurer, Ormoc City, with compensation at the rate of ₱1,200.00 per annum, is hereby created. This position is separate and distinct from that of the Market Superintendent. The powers and duties of the Market Inspector shall be as follows:

- (a) To record all market stalls with their corresponding daily cash tickets or monthly payment due the Government;
- (b) To record the number of stores in every section with their corresponding cash tickets daily;
- (c) To inspect all cash tickets issued to all market vendors every morning and afternoon;
- (d) To see to it that all market vendors operating business within the market are duly licensed;
- (e) To render a monthly report to the City Treasurer of the general operation in the market copy of which shall be furnished the Municipal Board;
- (f) To submit a monthly report to the City Treasurer, copy furnished the Municipal Board, of the collections paid to the City Government and those accruing the City Government unpaid, if any; and
- (g) To submit a report of his actuations from time to time to the Municipal Board.

SECTION 2. The sum of Four Hundred Pesos (₱400.00) is hereby appropriated from out of any funds existing in the city treasury not otherwise appropriated to cover the salary of the position hereby created from March 1, 1962, to June 30, 1962, and thereafter, the corresponding appropriation shall be provided in the succeeding city

budgets.


SECTION 3. This Ordinance shall take effect March 1, 1962.

ENACTED, March 2, 1962.




